The Ministry of Health and Local Government in pursuance of the powers conferred upon it by Section five of the Housing Act, 1921, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby orders as follows:

- 1. The rate of interest on advances to be made under Section 1 of the Small Dwellings Acquisition Act, 1899, on or after the twenty-fifth day of October, 1958, shall be (a) six per centum per annum for periods over five but not exceeding fifteen years and for periods over thirty but not exceeding fifty years; and (b) six and one-eighth per centum per annum for periods over fifteen but not exceeding thirty years.
- 2. The Rate of Interest (Housing) (No. 2) Order (Northern Ireland), 1958(a), made by the Ministry of Health and Local Government on the twenty-second day of August, 1958, is hereby revoked.
- 3. This Order may be cited as the Rate of Interest (Housing) (No. 3) Order (Northern Ireland), 1958.

ORDER* DATED 21ST APRIL, 1958, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT, WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTION ONE OF THE HOUSING (No. 2) ACT (NORTHERN IRELAND), 1946.

The Ministry of Health and Local Government (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance, in exercise of the powers conferred on the Ministry by section one of the Housing (No. 2) Act (Northern Ireland), 1946, and of every other power enabling it in that behalf, hereby makes the following Order:—

- 1. This Order may be cited as the Housing Subsidy Order (Northern Ireland), 1958, and shall be construed as one with the Housing Subsidy Order (Northern Ireland), 1956(a) (in this Order referred to as "the principal Order") and the Housing Subsidy Order (Northern Ireland), 1957(b).
- 2. In the principal Order the following Article shall be added after Article 4A:—
 - "4B. Where a new house of any area specified in the first column of the Second Schedule to this Order has been provided by a local authority in pursuance of a contract or part of a contract.
 - (a) which has been designated by the Ministry for the purposes of this Article; and
- (b) in respect of which the tender has been submitted for approval to the Ministry on or after the 15th day of March, 1958, and before the 1st day of January, 1959;
