## EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

The object of this Order is to extend to the 1st January, 1960, the date before which plans for the provision of houses and the reconditioning of premises as houses on farms must be submitted to the Ministry of Health and Local Government for approval in order to qualify for grant.

The Order also prescribes the rates of grant payable in respect of new farmhouses, approved worker's houses, and reconditioning works, and prescribes the dates before which work must be completed in order to qualify for the rates of grant specified.

The Ministry of Health and Local Government (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance, in exercise of the powers conferred on the Ministry by Section fifteen of the Housing (No. 2) Act (Northern Ireland), 1946, (in this Order referred to as "the No. 2 Act of 1946") and of every other power it thereunto enabling, hereby makes the following Order:—

Contributions payable to persons in respect of houses built for letting

1. The contributions payable by a local authority in respect of housing accommodation provided for workers in accordance with the provisions of sub-section (1) of Section one of the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1946, (in this Order referred to as "the Act of 1946") and the sums payable by the Ministry under sub-section (2) of Section one of the Act of 1946 to the local authority in respect of those contributions shall, in relation to each new house completed between the first day of January, nineteen hundred and fifty-nine and the thirty-first day of December, nineteen hundred and fifty-nine inclusive, and falling within any one of the three categories mentioned in the first column of the First Schedule to this Order, consist respectively of a single payment of the amount specified opposite such category in the second and third columns of the said Schedule.

Grants payable to persons in respect of houses built for owner-occupation

2. The grant payable by a local authority under sub-section (1) of Section six of the No. 2 Act of 1946 and the sum payable by the Ministry under sub-section (2) thereof to the local authority in respect of this grant shall, in relation to each new house completed between the first day of January, nineteen hundred and fifty-nine and the thirty-first day of December, nineteen hundred and fifty-nine inclusive, and falling within any one of the three categories mentioned in the first column of the Second Schedule to this Order, be respectively the amount specified opposite such category in the second and third columns of the said Schedule.

3. This Order may be cited as the Housing (Grants) Order (Northern Ireland), 1958.
