## WAKEHURST

Whereas under and by virtue of an Order in Council and Proclamation dated the 25th day of October, 1900, a Court for the hearing of Civil Bills only (hereinafter referred to as "the additional Civil Bill Court") is held four times in each year in and for the City of Londonderry, in addition to the Court held for the hearing of Civil Bills in and for the said City in the Hilary, Easter, Trinity and Michaelmas Quarters

And whereas by Order in Council dated the 27th day of July, 1937, further provision was made with respect to the times for holding the additional Civil Bill Court

And whereas it has been represented to the Minister of Home Affairs that the holding of the additional Civil Bill Court is unnecessary and should be discontinued

Now, therefore, I, John de Vere, Baron Wakehurst, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred on me by the Civil Bill Courts (Ireland) Act, 1851(a), the Chairman of Quarter Sessions (Ireland) Jurisdiction Act, 1876(b), the County Officers and Courts (Ireland) Act, 1877(c), and of all other powers me thereunto enabling do hereby order and direct as follows:—

1. From and after the First day of January, 1959, the additional Civil Bill Court in and for the City of Londonderry shall be discontinued.

2. The Order and Proclamation dated the 25th day of October, nineteen hundred (d), and the Order in Council dated the 27th day of July, nineteen hundred and thirty-seven, are hereby revoked.

3. This Order may be cited as the City of Londonderry Additional Civil Bill Court (Discontinuance) Order (Northern Ireland), 1958, and shall come into force on the 1st day of January, 1959.

### Black Scab in Potatoes

ORDER, DATED 15TH APRIL, 1958, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE DESTRUCTIVE INSECTS AND PESTS ACTS (NORTHERN IRELAND), 1877 TO 1934.

The Ministry of Agriculture, by virtue and in exercise of the powers vested in it under the Destructive Insects and Pests Acts (Northern Ireland), 1877 to 1934, and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows:—

#### *Short Title and Commencement*

1.—(1) This Order shall be cited as the Black Scab in Potatoes (Northern Ireland) Order, 1958.

(2) This Order shall come into operation on the 1st day of January, 1959.

#### *Amendment of the Black Scab in Potatoes (Northern Ireland) Consolidation Order, 1930(a)*

2. The Black Scab in Potatoes (Northern Ireland) Consolidation Order, 1930, shall be read and have effect as if the following were included in District No. 7 (Limavady Safety Zone) of the Sixth Schedule thereto:

“The townlands of (and all towns and villages included therein) Aughil, Ballycarton, Ballyleighery Lower, Ballymaclary, Ballymagoland, Ballymulholland, Ballymultimber, Ballyscullion, Bellarena, Benone, Carrowreagh (E.D. Bellarena), Clagan (E.D. Aghanloo), Clooney (E.D. Benone), Craig, Croaghan (E.D. Aghanloo), Doaghs Lower, Doaghs Lower Middle, Doaghs Upper, Doaghs Upper Middle, Drumahorgan, Drumavally, Drummans Lower, Drummans Middle, Drummans Upper, Drumnahay, Duncrun, Glebe (exclusive of Gort) (E.D.
