

REGULATIONS, DATED 14TH NOVEMBER, 1958, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION THIRTY-TWO OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1945.

I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs for Northern Ireland, in exercise of the powers vested in me by Section thirty-two of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945(a), (hereinafter referred to as "the Act") and of all other powers me thereunto enabling, do hereby make the following Regulations:—

1. The purchase of an article by any person at the request of the Ministry of Home Affairs or of the Inspector appointed under Section eight of the Pharmacy and Poisons Act (Northern Ireland), 1925(b), for the purpose of securing compliance with the provisions of Part III of the Act and the Regulations made thereunder shall be deemed not to be a purchase within the meaning of paragraph (b) of sub-section (5) of Section twenty-nine of the Act.

2. These Regulations may be cited as the Poison Regulations (Northern Ireland), 1958, and shall remain in force for a period of one year from the 1st December, 1958, unless sooner revoked.

REGULATIONS, DATED 18TH DECEMBER, 1958, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION THIRTY-TWO OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1945.

I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by section thirty-two of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945(a), (hereinafter referred to as "the Act") and of all other powers enabling me in that behalf do hereby make the following Regulations:—

1. The Poisons Regulations (Northern Ireland), 1956(c), shall have effect subject to the amendments specified in the schedule.

2. The Poisons (Amending) Regulations (Northern Ireland), 1958(d), are hereby revoked.

3. These Regulations may be cited as the Poisons (Amending) (No. 2) Regulations (Northern Ireland), 1958, and shall come into operation on the 1st day of February, 1959.
