EXPLANATORY NOTE

(This note is not part of the Scheme, but is intended to indicate its general purport.)

This scheme is made under Section 6 of the Agriculture Act (Northern Ireland), 1949, and provides for the payment of contributions to occupiers of not more than 50 acres of arable land in Northern Ireland, in respect of fertilisers bought by them between 1st July, 1958, and 30th June, 1959, inclusive, for improving the fertility of the soil.

The scheme which succeeds and is similar to the Agricultural Development (Fertiliser) Scheme (Northern Ireland), 1957, again provides for contribution at a reduced rate on nitrogenous, phosphatic and potassic fertilisers.

Provision is made to terminate the scheme during the operative period in the event of the introduction of a general scheme providing similar type of assistance to farmers.

The Ministry of Agriculture in exercise of the powers conferred on it by subsection (1) of Section 6 of the Agriculture Act (Northern Ireland), 1949, and of every other power enabling it in that behalf and with the approval of the Ministry of Finance, hereby makes the following Scheme:—

1. This scheme may be cited as the Agricultural (Marginal Production Seeds and Fertilisers) (Amendment) Scheme, (Northern Ireland), 1958, and shall come into operation on the 13th February, 1958.

2. The Agricultural (Marginal Production Seeds and Fertilisers) Scheme (Northern Ireland), 1956(a) is hereby varied as follows:—

In paragraph 4 which prescribes the maximum rate of assistance the figures "75" shall be substituted for the figures "85".

EXPLANATORY NOTE

(This Note is not part of the Scheme but is intended to convey its general purport.)

This Scheme made under Section 6 of the Agriculture Act (Northern Ireland), 1949, reduces the maximum rate of assistance given under the Agricultural (Marginal Production Seeds and Fertilisers) Scheme (Northern Ireland), 1956, towards the cost of Fertilisers and Grass Seeds purchased by certain classes of occupiers of lands in County Fermanagh and in certain District Electoral Divisions in the Rural District of Omagh in the County of Tyrone from 85 per cent. to 75 per cent. of the net cost of the goods.
