2. This Order may be cited as the Inland Navigation (Abandonment of the Lower Reaches of the Lagan Navigation) Order, 1958, and shall take effect on the 1st July, 1958.

## INTOXICATING LIQUOR

### Compensation: Charges in respect of Licences

ORDER, DATED 28TH MAY, 1958, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 3 OF THE INTOXICATING LIQUOR ACT (NORTHERN IRELAND), 1923, AS AMENDED BY THE INTOXICATING LIQUOR (FINANCE) ACT (NORTHERN IRELAND), 1925.

1. In pursuance of sub-sections (3)(b) and (4) of section three of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, the Ministry of Finance hereby prescribes that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending the 30th day of September, 1959, shall be eleven shillings for each pound sterling of the maximum rates of charge authorised by sub-section (1) of section one of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

2. This Order may be cited as the Intoxicating Liquor (Compensation Charges) Order (Northern Ireland), 1958.

### EXPLANATORY NOTE

*(This note is not part of the Order, but is intended to indicate its general purport.)*

The Order prescribes the rates at which charges for compensation are to be imposed in respect of licences for the sale of intoxicating liquor by retail to be granted or renewed during the year ending 30th September, 1959.

### JURORS

#### Service of Jurors' Summonses

REGULATIONS, DATED 2ND JANUARY, 1958, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION SEVEN OF THE JURIES ACT (NORTHERN IRELAND), 1953.

1958. No. 1

I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs, in exercise of the powers conferred on me by section seven of the Juries Act (Northern Ireland), 1953, and after consultation with the Lord Chief Justice of Northern Ireland, hereby make the following Regulations:—

1. These Regulations may be cited as the Jurors (Service of Summonses) Regulations (Northern Ireland), 1958, and shall come into operation on the 1st day of February, 1958.

2. The Under Sheriff of each county and county borough to whom the precept for the return of jurors before a court has been issued shall serve every summons for the attendance of a juror in any such court by causing the summons to be sent by prepaid post in an envelope addressed to the person and at the address named in the summons.

3. Every juror's summons shall be posted at least ten clear days before the day on which the juror is required to attend in the court.

4. Each Under Sheriff shall prepare a list of the names and addresses of the jurors to be summoned and shall present the list at a Head Post Office with the summonses at the time of posting and a certificate of posting endorsed on the said list by the Head Postmaster shall be evidence that the said summonses were duly posted.
