(b) those provisions of Part I of the Industrial Injuries Act which relate to the payment and recovery of contributions;

if no services are rendered by an insured person during any contribution week and the remuneration which he receives or is entitled (whether conditionally or not) to receive in respect of that week does not exceed forty shillings that remuneration shall be deemed not to be remuneration paid in respect of any day in that week."

Amendment of regulation 11 of the principal regulations

3. In the proviso to regulation 11 of the principal regulations (which provides that that regulation shall not apply to any week in respect of which payments do not exceed twenty shillings) for the words "twenty shillings" there shall be substituted the words "forty shillings".

## **EXPLANATORY NOTE**

(This note is not part of the regulations, but is intended to indicate their general purport.)

Under certain provisions of the National Insurance Act (Northern Ireland), 1946, and the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946, liability to pay contributions in respect of employed contributor's employment or insurable employment, as the case may be, does not arise for any week in which no services are rendered and no remuneration is paid.

These regulations provide that for the purposes of those provisions of those Acts, remuneration in respect of any week which does not exceed forty shillings shall be deemed not to be remuneration. They also increase to forty shillings the limit under which holiday payments are not deemed to be remuneration for those purposes.

## EDUCATION

## **Teachers' Courses**

REGULATIONS DATED 11TH FEBRUARY, 1959, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1958, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 59, 77 and 112 of the Education

Act (Northern Ireland), 1947(a), and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance, hereby makes the following Regulations:

- 1.—(1) These Regulations may be cited as the Training of Teachers (Courses) Amending Regulations (Northern Ireland), 1959.
- (2) The existing Regulations hereby amended are the Training of Teachers (Courses) Regulations (Northern Ireland), 1957(b).
- (3) These Regulations shall come into operation on the 1st day of September, 1959.
- 2. Regulations 2, 4 and 5 of the existing Regulations are hereby revoked and the following substituted therefor:—
  - "2. In these Regulations, unless the context otherwise requires, "recognised" means recognised by the Ministry.
  - 4. The Ministry may make grants at rates approved by the Ministry of Finance towards the necessary expenses incurred by teachers in attending approved courses, and where for the purpose of attendance at such a course a teacher is released from his teaching duties without salary, the amount of such grant may be determined by reference to the rate of salary (exclusive of allowances) payable to him immediately before entering upon the course.

Provided that grant at such rate as may be determined by the Ministry may be paid to a teacher who is not employed in a permanent capacity and who is admitted to an approved course.

5. To be eligible to receive grant calculated by reference to his rate of salary a teacher must have completed at least five years' approved teaching service:

## Provided that-

- (1) this requirement shall not apply in the case of
- (a) a teacher who is selected by the Ministry to attend a special course in order to qualify as a teacher in a special school or a secondary intermediate school or to enrol in an approved university course leading to the award of a Bachelor of Education Degree; or
- (b) a teacher who, although entitled to recognition as a qualified teacher, has not successfully completed an approved course of training extending over at least one training college session and who is selected by the Ministry to attend a special course;
- (2) service in Her Majesty's Forces shall be deemed to be approved teaching service for the purpose of these Regulations."
