## **Register** of Electors

REGULATIONS, DATED 8TH AUGUST, 1960, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTIONS SIXTEEN AND FIFTY-FOUR OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946.

The Ministry of Home Affairs, in exercise of the powers vested in it by sections sixteen and fifty-four of the Elections and Franchise Act (Northern Ireland), 1946(a), and of every other power it thereunto enabling, hereby makes the following Regulations:—

#### Citation and commencement

1. These Regulations may be cited as the Electoral (Registration) (Amendment of Time-table) Regulations (Northern Ireland), 1960, and shall come into operation on 1st September, 1960.

#### Amendment of Time-table

2. The Electoral (Registration) Regulations (Northern Ireland), 1954(b), shall have effect as though—

(1) in regulation 8 for the references to the 16th November and the 11th December wherever they occur there were substituted respectively references to the 5th November and the 30th November;

(2) for the First Schedule there were substituted the Schedule to these Regulations.
