all other powers enabling us in that behalf, by and with the advice of the Privy Council of Northern Ireland, do hereby order as follows:

- 1. This Order may be cited as the National Insurance (Employment by or under the Crown) Order (Northern Ireland), 1960.
- 2.—(1) For the purposes of Part II of the National Insurance Act (Northern Ireland), 1959, (which makes provision as to non-participating employments) the Ministry of Finance shall be deemed to be the employer of any person employed by or under the Crown to whom any relevant statutory provision applies.
- (2) For the purposes of this Article a relevant statutory provision is one which relates to the superannuation of—
 - (a) the civil service of Northern Ireland;
 - (b) the Royal Ulster Constabulary or the Ulster Special Constabulary;
 - (c) any person appointed to the office of clerk of petty sessions or deputy or assistant clerk of petty sessions.

DISEASES OF ANIMALS ACT

Eradication of Bovine Tuberculosis

ORDER, DATED 7TH OCTOBER, 1960, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 53 OF THE DISEASES OF ANIMALS ACT (NORTHERN IRELAND), 1958(a).

The Ministry of Agriculture, in exercise of the powers conferred on it by Section fifty-three of the Diseases of Animals Act (Northern Ireland), 1958, and of every other power enabling it in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Tuberculosis (Possession of Untested Animals) (No. 2) Order (Northern Ireland), 1960, and shall come into operation on the 10th day of October, 1960.

Interpretation

- 2. In this Order:
- "Act" means the Diseases of Animals Act (Northern Ireland), 1958;
- "animal" means a bovine animal;

- "herd" means a herd of one or more bovine animals;
- "premises" means any buildings, field or other enclosure;
- "untested animal" means an animal which has not been subjected to a tuberculin test and includes an animal to which Article 3 applies.

Notification of Untested Animals

- 3. Where any person occupying premises in the eradication area of Counties Armagh, Down, Tyrone and Fermanagh and the County Borough of Belfast has on the said premises any animal which:
 - (a) is in a herd or on premises not registered by the Ministry under the provisions of the Tuberculosis (Attested Herds) (Northern Ireland) Scheme, 1959(a), or the Tuberculosis (Area Eradication) Order (Northern Ireland), 1959(b); or
 - (b) being in a herd which has been registered by the Ministry under the said Scheme or Order, has been brought into the said herd without the authority of a movement licence or permit; or
- (c) has at any time shown a positive reaction to a tuberculin test; he shall notify the Ministry in writing before 24th October, 1960, of the number and description of such animals in his possession and of the premises on which they are kept and such animals shall for the purposes of this Order be deemed to be untested.

Offence

4. From 24th October, 1960, it shall be an offence against the Act for any person to have on premises within the eradication area consisting of the Counties of Armagh, Down, Tyrone and Fermanagh and the County Borough of Belfast an untested animal, unless he has notified the Ministry of his possession of such untested animal in accordance with the provisions of Article 3.

Application 1

- 5. This Order shall not apply:
- (1) To a calf born on premises registered by the Ministry under the Tuberculosis (Attested Herds) (Northern Ireland) Scheme, 1959, or the Tuberculosis (Area Eradication) Order (Northern Ireland), 1959, since the date when the last herd test was completed or to an animal introduced to such premises under the authority of a valid movement licence or permit; or
- (2) To an animal which has reacted to a tuberculin test and is being dealt with by the Ministry under the Tuberculosis (Slaughter and Compensation) Order (Northern Ireland), 1959(c).
