- (i) at age 15 from the beginning of the day following that on which a qualified pupil attains the upper limit of the compulsory school age;
- (ii) at age 16 from the beginning of the day following the anniversary of the date on which a qualified pupil attains the upper limit of the compulsory school age;
- (iii) at age 17 and over from the beginning of the day following the second anniversary of the date on which a qualified pupil attains the upper limit of the compulsory school age.

Nurses (Registration of Male Nurses) Rules, Approval Order

ORDER, DATED 31ST MARCH, 1960, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT, UNDER SECTION 57 OF THE NURSES AND MIDWIVES ACT (NORTHERN IRELAND), 1959.

Whereas the Joint Nursing and Midwives Council for Northern Ireland have, in exercise of their powers under sub-Section 1 of Section 8 and Section 57 of the Nurses and Midwives Act (Northern Ireland), 1959(a), made the Nurses (Registration of Male Nurses) Rules (Northern Ireland), 1960, and have submitted the said Rules to the Ministry of Health and Local Government (in this Order referred to as "the Ministry") for approval:

Now, therefore, the Ministry, in exercise of the powers conferred upon it by Section 57 of the Nurses and Midwives Act (Northern Ireland), 1959, hereby orders as follows:—

1. This Order may be cited as the Nurses (Registration of Male Nurses) Rules (Northern Ireland), 1960, Approval Order (Northern Ireland), 1960.

2. The Ministry hereby approves the said Rules in the form set out in the Schedule hereto.

SCHEDULE

THE JOINT NURSING AND MIDWIVES COUNCIL FOR NORTHERN IRELAND THE NURSES AND MIDWIVES ACT (NORTHERN IRELAND), 1959

The Joint Nursing and Midwives Council for Northern Ireland in exercise of the powers conferred on them by Sections 8(1) and 57(1) of the Nurses and Midwives Act (Northern Ireland), 1959, hereby make the following rules:—

1. These Rules may be cited as the Nurses (Registration of Male Nurses) Rules (Northern Ireland), 1960.

2.-(1) The names of male nurses who have satisfied the conditions of admission of nurses to the general part of the Register shall be registered in that part of the Register, so that the general part of the Register shall contain the names of both male and female general nurses.

(2) The particulars of each male nurse already registered in the supplementary part of the Register containing the names of male nurses shall be transferred to the general part of the Register and the supplementary part shall cease to exist.

3. Rule 4(1)(i)(b) of the Nurses Rules (Northern Ireland), 1954, is hereby revoked.
