Counties of Antrim and Londonderry and the County Borough of Londonderry an untested animal, unless he has notified the Ministry of his possession of such untested animal in accordance with the provisions of Article 3.

Application

- 5. This Order shall not apply:
- (1) To a calf born on premises registered by the Ministry under the Tuberculosis (Attested Herds) (Northern Ireland) Scheme, 1959, or the Tuberculosis (Area Eradication) Order (Northern Ireland), 1959, since the date when the last herd test was completed or to an animal introduced to such premises under the authority of a valid movement licence or permit; or
- (2) To an animal which has reacted to a tuberculin test and is being dealt with by the Ministry under the Tuberculosis (Slaughter and Compensation) Order, 1959(a).

EDUCATION

Teachers' Compulsory Absence and Special Sick Leave Amending Regulations

REGULATIONS, DATED 13TH JUNE, 1960, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1958, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 84, 104 and 112 of the Education Act (Northern Ireland), 1947, (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Teachers' Compulsory Absence and Special Sick Leave Amending Regulations (Northern Ireland), 1960.

- (2) These Regulations shall have effect from 1st August, 1960.
- 2. The Regulations hereby amended are the Teachers' Compulsory Absence and Special Sick Leave Regulations (Northern Ireland), 1954(a).
- 3. For paragraph (1) of Regulation 5 of the principal Regulations there shall be substituted the following:—
 - "(1) A full-time teacher, who, before the relevant date, has completed an undertaking to submit himself to an X-ray examination of the chest when called upon by the Authority to do so and to such other examinations as the Authority may consider necessary, and who has submitted himself to such examination or examinations when invited to do so by the Authority shall, if suspended from duty under the provisions of Regulation 3 of these Regulations, be entitled, by virtue of this paragraph, but not otherwise, to special sick leave for a period not exceeding eighteen months from the date of such suspension: provided that if a teacher, as an alternative to examination by the Authority, elects, at his own expense to be examined by a physician nominated by the teacher and approved by the Authority, he may do so and shall thereby be deemed to have complied with the requirements of this paragraph."

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations remove the obligation placed upon a teacher to submit himself each year for X-ray examination of the chest if, in the opinion of the Authority, examination at intervals less frequent than one year is required.
