

## EXPLANATORY NOTE

*(This Note is not part of the regulations, but is intended to indicate their general purport.)*

These regulations—

- (a) revoke the provisions of the Public Health (Preservatives, etc., in Food) (Northern Ireland) Regulations, 1927, as amended, relating to colouring matter in food (Regulation 3 and the Third Schedule);
- (b) prohibit the sale of food containing any added colouring matter other than that specified in the First Schedule (Regulation 5 and the First Schedule);
- (c) prohibit the sale of certain raw and unprocessed foods having in or upon them, otherwise than for marking purposes, any added colouring matter at all, except that citrus fruit may have permitted colouring if this is suitably indicated in accordance with the regulations (Regulation 6);
- (d) prohibit the sale or advertising for sale of any food colouring matter which is not a permitted colouring matter and impose requirements as to the labelling of permitted colouring matter and colouring and flavouring compounds (Regulation 7);
- (e) provide that where certain food is certified by a public analyst as containing colouring matter not permitted by the regulations that food may be treated for the purposes of Section 9 of the Food and Drugs Act (Northern Ireland), 1958, as being unfit for human consumption (Regulation 8);
- (f) do not apply to food or colouring matter intended for export.

**DISEASES OF ANIMALS ACT****Eradication of Bovine Tuberculosis**

ORDER, DATED 5TH APRIL, 1961, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 23 OF THE DISEASES OF ANIMALS ACT (NORTHERN IRELAND), 1958(a).

The Ministry of Agriculture in exercise of the powers conferred on it by section twenty-three of the Diseases of Animals Act (Northern Ireland), 1958, and of every other power enabling it in that behalf hereby makes the following Order:—

*Citation and commencement*

1. This Order may be cited as the Tuberculosis (Entry of Attested Animals) Order (Northern Ireland), 1961, and shall come into operation on the first day of May, 1961.

*Interpretation***2. In this Order:—**

“animal” means bovine animal;

“attested animal” means an animal moved under the conditions of a permit from a herd accepted as attested in a certificate issued in accordance with the requirements of the Tuberculosis (Attested Herds) (Northern Ireland) Scheme, 1959(a), or of the Attested Herds Scheme of the Government of the Republic of Ireland or from any herd of equivalent status;

“point of entry” has the meaning assigned to it in the Imported Livestock Order, 1958(b);

“scheduled point of entry” means a point of entry as designated in the First Schedule for the entry of attested animals;

“entry” means entry into Northern Ireland from the Republic of Ireland and “enter” shall be construed accordingly.

*Points of Entry*

3.—(1) Attested animals shall not enter at any place other than at a scheduled point of entry or at a point of entry designated in the Second Schedule.

(2) The points of entry designated in the First Schedule shall not be used by any animals other than attested animals and shall not be used except on the days and at the times specified in that Schedule. These days and times may however be altered by the Ministry by the display of notices indicating such alterations at any particular point of entry.

(3) The points of entry designated in the Second Schedule may be used by attested animals subject to the conditions specified in that Schedule.

*Disinfection*

4. The premises at a point of entry designated in the Second Schedule shall, before use by attested animals, be disinfected in accordance with such instructions as may from time to time be issued by the Ministry.

*Closure of Points of Entry*

5. The Ministry may at any time close any one or more of the points of entry specified in the First and Second Schedules, either temporarily or permanently, for the entry of attested animals.

*Revocations*

6. The Tuberculosis (Entry of Attested Animals) Order (Northern Ireland), 1960(c), is hereby revoked as from the commencement of this Order, but without prejudice to anything duly done thereunder.

## FIRST SCHEDULE

The following are hereby designated to be scheduled points of entry and shall be open for the entry of attested animals on the days and at the times stated:—

<i>Name of Scheduled Point of Entry</i>	<i>Days and Times</i>
Belleek (Corry), Co. Fermanagh ..	Monday-Friday, 9.0-10.0 a.m.
Culmore, Co. Londonderry .. ..	Monday-Friday, 9.15-10.15 a.m.
Tullydonnell (Gage), Co. Armagh ..	Wednesday, 4.0-5.0 p.m.
Galliagh Road, Co. Londonderry ..	Monday-Saturday, 11 a.m.-12 noon and 2 p.m.-3 p.m. (1.30 p.m.-3.30 p.m. on the 8th, 15th and 23rd of each month)

## SECOND SCHEDULE

The points of entry listed below may be used for the entry of attested animals, provided that—

- (a) notice of the proposed date of entry of the attested animals shall be given at least five days in advance by the owner of the animals; and
- (b) the animals shall be presented at the point of entry on the day approved and at the time notified by the Ministry.

Middletown, Co. Armagh.

Belcoo East, Co. Fermanagh.

Clontivrin, (Clonmackan), Co. Fermanagh.

Mullan, (Drumcullion), Co. Fermanagh.

## EXPLANATORY NOTE

*(This note does not form part of the Order, but is intended to indicate its general purport.)*

This Order designates four scheduled points of entry from the Republic of Ireland into Northern Ireland which shall be reserved exclusively for attested cattle. Nine further points of entry may be used by attested cattle provided that the Ministry receives at least five days' notice.
