## DISEASES OF ANIMALS ACT

### Eradication of Bovine Tuberculosis

ORDER, DATED 30TH MAY, 1961, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 3 OF THE DISEASES OF ANIMALS ACT (NORTHERN IRELAND), 1958(a).

The Ministry of Agriculture in exercise of the powers conferred on it by Section 3 of the Diseases of Animals Act (Northern Ireland), 1958, and of every other power enabling it in that behalf hereby makes the following Order:—

#### *Citation and commencement*

1. This Order may be cited as the Tuberculosis (Movement of Cattle) (No. 2) (Amendment) Order (Northern Ireland), 1961, and shall come into operation on the 3rd day of July, 1961.

#### *Amendment of Principal Order*

2. For Article 4 of the Tuberculosis (Movement of Cattle) (No. 2) Order (Northern Ireland), 1960(b), the following Article shall be substituted:—

#### *“Restriction on Shipment*

4. An animal shall not be shipped to Great Britain unless it is an attested animal and is:—

(a) 1958. c. 13.

(b) S.R. & O. (N.I.) 1960, No. 78.

- (a) accompanied by :—
- (i) a movement permit issued in accordance with the conditions of the Tuberculosis (Attested Herds) (Northern Ireland) Scheme, 1959(a), or of the Attested Herds Scheme of the Republic of Ireland, or
  - (ii) a movement licence issued in accordance with the conditions of the Bovine Tuberculosis (Eradication) Scheme of the Republic of Ireland, and
- (b) it is suitably marked, for identification purposes, in such a manner as the Ministry may from time to time direct."
