### DESTRUCTIVE INSECTS AND PESTS

## Landing of Unbarked Coniferous Timber

Order, dated 22nd day of June, 1961, made by the Ministry of Agriculture under the Destructive Insects and Pests Acts (Northern Ireland), 1877 to 1934.

The Ministry of Agriculture in exercise of the powers conferred on it by Sections 1 and 2 of the Destructive Insects Act, 1877(a), as amended by Section 1

of the Destructive Insects and Pests Act, 1907(a), and Section 1 of the Destructive Insects and Pests Act (Northern Ireland), 1934(b), and of every other power enabling it in that behalf, hereby makes the following Order:—

#### Citation and commencement

1. This Order may be cited as the Landing of Unbarked Coniferous Timber Order (Northern Ireland), 1961, and shall come into operation on the 1st day of July, 1961.

# Interpretation

- 2. In this Order—
- "authorised officer" means an officer of the Ministry authorised for the purposes of this Order;
- "importer", in relation to unbarked coniferous timber, includes any person who, whether as owner, consignor or consignee, agent or broker, is for the time being in possession of, or in any way entitled to the custody or control of, the unbarked timber;
- "unbarked coniferous timber" means logs or poles from trees of any of the coniferous species in the round with some or all of the bark still present;
- "landing" includes importation into Northern Ireland by any method whatsoever.

### Prohibition of Landing

- 3.—(1) The landing in Northern Ireland of unbarked coniferous timber grown in or brought from any of the countries specified in the Schedule to this Order is hereby prohibited.
- (2) For the purposes of this Order timber shall not be taken to be brought from a country by reason only that the vessel in which the timber is shipped calls at a port in such country in the course of its voyage to Northern Ireland, if the timber is not unloaded at such port; but timber which is so unloaded and is subsequently re-shipped shall be deemed to have been brought to Northern Ireland from such country.

# Procedure when produce is landed in contravention of this Order

4. If any unbarked coniferous timber is landed in Northern Ireland in contravention of this Order, it shall either be destroyed by the importer or be re-exported by him from the port of landing not later than seven days after the day on which it was so landed and, if after the expiration of that period the timber has not been so destroyed or re-exported, any authorised officer may destroy the timber by such means as he thinks fit or cause it to be so destroyed and the Ministry may recover from the importer any expenses reasonably incurred in connection with its destruction.

### Entry and Examination

5. An authorised officer, upon production if so required of his authority, may enter any premises on which he has reasonable grounds for believing that any unbarked coniferous timber is situated, being timber that has been landed in Northern Ireland in contravention of this Order or that he suspects has been so landed, and may examine any such coniferous timber that he finds there.
