SUMMARY JURISDICTION**Petty Sessions Districts and Times**

ORDER, DATED 26TH JUNE, 1961, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SUB-SECTION (1) OF SECTION TEN OF THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

The Ministry of Home Affairs in exercise of the powers conferred on it by sub-section (1) of section ten of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935(a), and of all other powers enabling it in that behalf, after consultation with the County Court Judges and Resident Magistrates concerned, hereby orders and directs as follows:—

Citation and commencement

1. This Order may be cited as the Petty Sessions Districts and Times (Trillick) Order (Northern Ireland), 1961, and shall come into operation on the 2nd day of October, 1961.

Alteration of Trillick Petty Sessions District

2.—(1) The townlands set forth in the First Schedule at present forming part of the Petty Sessions District of Trillick shall be added to and form part of the Petty Sessions District of Lisbellaw.

(2) The townlands set forth in the Second Schedule at present forming part of the Petty Sessions District of Trillick shall be added to and form part of the Petty Sessions District of Fintona.

(3) The townlands set forth in the Third Schedule at present forming part of the Petty Sessions District of Trillick shall be added to and form part of the Petty Sessions District of Dromore (County Tyrone).

Alteration of Irvinestown Petty Sessions District

3.—(1) The townlands set forth in the Fourth Schedule at present forming part of the Petty Sessions District of Irvinestown shall be added to and form part of the Petty Sessions District of Dromore (County Tyrone).

Abolition of Trillick Petty Sessions District

4. The Petty Sessions District of Trillick is hereby abolished.
