**WAGES COUNCILS****Wages Regulation (Baking)**

ORDER, DATED 22ND NOVEMBER, 1961, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE WAGES COUNCILS ACT (NORTHERN IRELAND), 1945.

The Ministry of Labour and National Insurance, in exercise of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland), 1945(a), hereby makes the following Order to give effect to wages regulation proposals received from the Baking Wages Council (Northern Ireland):—

*Citation*

1. This Order may be cited as the Baking Wages Regulation (Amendment) (No. 10) Order (Northern Ireland), 1961.

*Commencement*

2. The wages regulation proposals set out in the Schedule shall come into operation on the specified date and on the day immediately preceding that date the Baking Wages Regulation (Amendment) (No. 1) Order (Northern Ireland), 1961(b), shall cease to have effect.

*Interpretation*

3. In this Order the expression "the specified date" means the 20th day of December, 1961, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

**Statutory Minimum Remuneration for certain Male Workers employed in the County of the City of Belfast and in Districts situate within a Radius of 15 Statute Miles therefrom**

2. in paragraphs 7 and 8, for the figure '44', wherever it occurs, there were substituted the figure '43.'

3. for paragraphs 9 and 10 there were substituted the following paragraphs—  
"Paragraph 9.

Subject to the provisions of paragraph 10 overtime rates are payable as follows:—

(1) (a) On Monday, Tuesday and Friday (not being customary holidays)—

For the first two hours worked in excess  
of 8 hours .. .. . TIME-AND-A-QUARTER  
Thereafter .. .. . TIME-AND-A-HALF

(b) On Wednesday and Thursday (not being customary holidays)—

For the first two hours worked in excess  
of 7½ hours .. .. . TIME-AND-A-QUARTER  
Thereafter .. .. . TIME-AND-A-HALF

Provided that where it is or may become the established practice of an employer to require the worker's attendance on only five days in the week, the said overtime rates of time-and-a-quarter and time-and-a-half are payable on each of the days Monday to Thursday after 8½ and 10½ hours' work respectively, and on Friday after 9 and 11 hours' work respectively.

(2) On the weekly short day (not being a Sunday or a customary holiday)—

For the first two hours worked in excess  
of 4 hours .. .. . TIME-AND-A-QUARTER  
Thereafter .. .. . TIME-AND-A-HALF
