HOUSING

Housing Subsidy Order

ORDER*, DATED 12TH DECEMBER, 1961, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT, WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTION 1 OF THE HOUSING (NO. 2) ACT (NORTHERN IRELAND), 1946.

The Ministry of Health and Local Government (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance, in exercise of the powers conferred on the Ministry by Section 1 of the Housing (No. 2) Act (Northern Ireland), 1946(a), and of every other power enabling it in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Housing Subsidy Order (Northern Ireland), 1961, and shall be construed as one with the Housing Subsidy Order (Northern Ireland), 1956(b) (in this Order referred to as "the principal Order").

PART I

2. This part of this Order shall apply to a housing scheme in respect of which the tender has been submitted to the Ministry for approval on or after 1st April, 1961.

3. The amount of contributions set out in the Second Schedule to the principal Order shall be amended by substituting therefor the amount of contributions set out in the First Schedule.

4. In Article 5 of the principal Order for the sums of "eighteen pounds" and "six pounds" there shall be substituted respectively the sums of "twenty-one pounds" and "seven pounds".

5. In paragraph (2) of Article 8A of the principal Order for the sums of "twenty-seven pounds" and "nine pounds" there shall be substituted respectively the sums of "thirty-one pounds ten shillings" and "ten pounds ten shillings".

6. In paragraph (3) of Article 8A of the principal Order for the sums of "twenty-one pounds" and "seven pounds" there shall be substituted respectively the sums of "twenty-four pounds ten shillings" and "eight pounds three shillings".

PART II

7. In addition to each annual contribution payable under the principal Order special annual contributions shall be payable in respect of each new house the building of which is commenced between 30th June, 1961, and 1st July, 1962, and completed before 1st April, 1963.

8. The amounts of the special annual contributions referred to in Article 7 shall be as follows:—

*The above Order was confirmed by Resolutions of the Senate and of the House of Commons on the 30th day of January, 1962.

(1) The additions to the amounts referred to in Article 4 of the principal Order shall be the corresponding amounts set out in the Second Schedule.

(2) The additions to the amounts referred to in Article 5 of the principal Order shall be five pounds and one pound thirteen shillings payable respectively by the Ministry and the local authority.

(3) The additions to the amounts referred to in paragraph (2) of Article 8A of the principal Order shall be seven pounds twelve shillings and sixpence and two pounds eleven shillings payable respectively by the Ministry and the local authority.

(4) The additions to the amounts referred to in paragraph (3) of Article 8A of the principal Order shall be five pounds seventeen shillings and one pound nineteen shillings payable respectively by the Ministry and the local authority.
