EXPLANATORY NOTE

(This Note is not part of the rules but is intended to indicate their general purport.)

These rules provide that any officer in the employment of a local authority who does not participate in the National Insurance Graduated Pension Scheme in due course and who becomes eligible to allocate part of his pension in accordance with the provisions of the Local Government Superannuation (Allocation of Pension) Rules (Northern Ireland), 1950, will be able to allocate only so much of his pension in favour of a beneficiary as will leave payable to him an amount equivalent at least to that which would be available under the Graduated Pension Scheme.

The rules also amend the conditions under which an allocation of pension may be cancelled or varied.

ROAD TRAFFIC

Speed Limits

ORDER, DATED 28TH FEBRUARY, 1961, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SUB-SECTION (4) OF SECTION TWENTY-THREE OF THE ROAD TRAFFIC ACT (NORTHERN IRELAND), 1955.

The Ministry of Home Affairs in exercise of the powers conferred on it by sub-section (4) of section twenty-three of the Road Traffic Act (Northern

Ireland), 1955(a), and of all other powers enabling it in that behalf, hereby orders and directs as follows:

Citation and commencement

1. This Order may be cited as the Roads (Speed Limit) Order (Northern Ireland), 1961, and shall come into operation on 1st May, 1961.

Revocation of Previous Directions

2. The directions contained in the Roads (Speed Limit) Order (Northern Ireland), 1956(b), relative to the lengths of road specified in the First Schedule to this Order are hereby revoked.

Speed Restrictions on Certain Roads

3. Each of the lengths of road specified in the Second Schedule shall be a restricted road for the purposes of the said section twenty-three.

De-restriction of Certain Roads

4. Each of the lengths of road specified in the Third Schedule shall not be a restricted road for the purposes of the said section twenty-three.

FIRST SCHEDULE

- (6) Portmore Road, Lower Ballinderry, Co. Antrim, from the junction with the Aghalee-Crumlin Road, Class I No. A.26 (now Class II No. B.12), to a point approximately 350 yards west of this junction.

- (7) Crawfordsburn Road, Class II No. B.20, Bangor, Co. Down, from the junction with McMurry's Lane, Bangor, to a point approximately 770 yards west of this junction.
- (8) Portrush Road, Class I No. A.2, Portstewart, Co. Londonderry, from a point approximately 115 yards north-east of the junction with Station Road and Portmore Road to a point approximately 942 yards north-east of this junction.
- (9) The Portrush-Portstewart Road, Class I No. A.2, Co. Londonderry, from the Londonderry County Boundary to a point approximately 1,308 yards north-east of the junction with Station Road, Portstewart.
- (10) Dublin Road, Trunk Road No. T.3, Omagh, Co. Tyrone, from the junction with Golf Links Lane to a point approximately 750 yards south-east of this junction.
