ROYAL ULSTER CONSTABULARY

Promotion Examination Allowance

ORDER, DATED 18TH MAY, 1962, MADE BY THE MINISTER OF HOME AFFAIRS UNDER THE CONSTABULARY AND POLICE (IRELAND) ACT, 1919, AS APPLIED BY THE CONSTABULARY ACT (NORTHERN IRELAND), 1922.

I, the Right Honourable Brian Faulkner, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by section two of the Constabulary Act (Northern Ireland), 1922(a), and by sub-section (1) of section four of the Constabulary and Police (Ireland) Act, 1919(b), as applied by the said Act of 1922, and of all other powers enabling me in that behalf, do hereby order as follows:---

Citation

1. This Order may be cited as the Royal Ulster Constabulary Allowances (Promotion Examination) Order, 1962.

Definitions

2. In this Order the following expressions shall have the meanings hereby respectively assigned to them:—

"code regulation" means a regulation forming part of the code of regulations

- made by the Inspector General under Section 6 of the Constabulary (Ireland) Act, 1836(c), as applied by the Constabulary Act (Northern Ireland), 1922.
- "constable", "sergeant" and "member" mean respectively, unless the contrary intention appears, a constable, sergeant and member of the
 - Royal Ulster Constabulary.
- "technical examination" means the relevant technical examination as defined in the code regulations.

Allowances

3. There shall be payable to the following members a promotion examination allowance of $\pounds 30:$ —

(a) a male constable who on or after the 1st January, 1961, has taken or takes Part II of the technical examination for constables in accordance with the code regulations and qualifies thereat:

Provided that such allowance shall not be payable where he has taken the said Part II prior to the 1st January, 1961, and has qualified thereat, or where he has, whilst serving in a police force, service in which may be reckonable as pensionable service for the purposes of the Royal Ulster Constabulary Pensions Order, 1949(a), already received a payment for passing the examination which qualifies him for promotion from the rank of constable to that of sergeant in that police force.

(b) a male sergeant who on or after the 1st January, 1961, has taken or takes Part II of the technical examination for sergeants in accordance with the code regulations and qualifies thereat:

Provided that such allowance shall not be payable where he has taken the said Part II prior to the 1st January, 1961, and has qualified thereat or where he has, whilst serving in a police force, service in which may be reckonable as pensionable service for the purposes of the Royal Ulster Constabulary Pensions Order, 1949, already received a payment for passing the examination which qualifies him for promotion from the rank of sergeant to the next senior rank in that police force.

(c) a woman constable who on or after the 1st January, 1961, has taken or takes Part I of the technical examination for constables in accordance with the code regulations and qualifies thereat:

Provided that such allowance shall not be payable where she has taken the said Part I prior to the 1st January, 1961, and has qualified thereat. or where she has, whilst serving in a police force, service in which may be reckonable as pensionable service for the purposes of the Royal Ulster Constabulary Pensions Order, 1949, already received a payment for passing the examination which qualifies her for promotion from the rank of constable to that of sergeant in that police force.

(d) a woman sergeant who on or after the 1st January, 1961, has taken or takes Part I of the technical examination for sergeants in accordance with the code regulations and qualifies thereat:

Provided that such allowance shall not be payable where she has taken the said Part I prior to the 1st January, 1961, and has qualified thereat or where she has, whilst serving in a police force, service in which may be reckonable as pensionable service for the purposes of the Royal Ulster Constabulary Pensions Order, 1949, already received a payment for passing the examination which qualifies her for promotion from the rank of sergeant to the next senior rank in that police force.

Limitation on number of payments

4.—(1) The said allowance shall be payable once only to a member in the rank of constable and once only in the rank of sergeant.

(2) Payment of the said allowance shall not be repeated if the relevant examinations are passed on more than one occasion or if examinations are taken in the same rank in different forces.

Transferred members

5. The said allowance shall be payable to a member who, after taking that part of the technical examination which qualifies for promotion, is transferred to a regular police force in Great Britain before the promulgation of the results of the examination at which the member qualifies.
