REGULATIONS, DATED 10TH JULY, 1962, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE YOUTH EMPLOYMENT SERVICE ACT (NORTHERN IRELAND), 1961.

The Ministry of Labour and National Insurance, in exercise of the powers conferred by sub-section (1) of section 13 of the Youth Employment Service Act (Northern Ireland), 1961(a), and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Youth Employment Service (Administrative Expenses) Regulations (Northern Ireland), 1962, and shall come into operation on the 1st September, 1962.

(2) In these regulations—

- "the Act" means the Youth Employment Service Act (Northern Ireland), 1961;
- "the Board" means the Northern Ireland Youth Employment Service Board;

"the Ministry" means the Ministry of Labour and National Insurance for Northern Ireland.

2. The estimate of income and expenditure of the Board required to be submitted to the Ministry under the provisions of sub-section (1) of section 13 of the Act shall be in such form as to show in respect of each financial year—

- (1) (a) expenditure under paragraph (c) of sub-section (2) of section 3 of the Act;
 - (b) expenditure under section 6 of the Act;
 - (c) expenditure under sub-section (1) of section 7 of the Act.
- (2) (a) expenditure by way of salaries and wages of officers;
 - (b) expenditure by way of national insurance employers' contributions;
 - (c) expenditure under the Local Government (Superannuation) Act (Northern Ireland), 1950(b);
 - (d) expenditure by way of travelling and other expenses of officers;
 - (e) expenditure in respect of office accommodation including loan charges, furniture and equipment, rent, rates and taxes, upkeep of buildings (including repairs and insurance), telephone and fuel, light and cleaning;
 - (f) expenditure in respect of printing and other expenses including printing, stationery, advertising and postage and poundage;
 - (g) other expenditure and the several categories under which the said expenditure is expected to be disbursed and the amount expected to be disbursed in each such category but excluding any estimated capital expenditure.

- (3) (a) income from sources other than grants from the Ministry or from Local Authorities and the source or sources from which such income is expected to be derived, and the amount expected to be derived from each source;
 - (b) capital expenditure and the several categories under which the said expenditure is expected to be disbursed and the amount expected to be disbursed in each such category.

3. The estimate of income and expenditure in respect of each financial year prepared and calculated as in regulation 2 of these regulations, shall be submitted to the Ministry for approval not later than the 31st day of October in the preceding financial year and shall be accompanied by a revised estimate of income and expenditure in respect of the current financial year.
