Small Dwellings Acquisition—Rate of Interest

ORDER, DATED 17TH AUGUST, 1962, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTION 5 OF THE HOUSING ACT, 1921.

The Ministry of Health and Local Government in pursuance of the powers conferred upon it by Section 5 of the Housing Act, 1921(a), and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby orders as follows:

1. This Order may be cited as the Rate of Interest (Housing) (No. 2) Order (Northern Ireland), 1962.

2. Notwithstanding any contracts entered into or applications granted under Section 1 of the Small Dwellings Acquisition Act, 1899(b), prior to the 17th day of August, 1962, the rate of interest on advances made under the said Section 1 on or after the 17th day of August, 1962, shall be six and seven-eighths per centum per annum.

3. The Rate of Interest (Housing) Order (Northern Ireland), 1962(c), made by the Ministry of Health and Local Government on the 6th day of April, 1962, is hereby revoked.

REGULATIONS, DATED 20TH AUGUST, 1962, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SUB-SECTION (6) OF SECTION THREE, SUB-SECTION (4) OF SECTION SIXTY-FIVE, SECTION ONE HUNDRED AND TWENTY-SEVEN OF AND THE THIRD SCHEDULE TO THE ELECTORAL LAW ACT (NORTHERN IRELAND), 1962.

The Ministry of Home Affairs in exercise of the powers conferred on it by sub-section (6) of section three, sub-section (4) of section sixty-five, section one hundred and twenty-seven of and the Third Schedule to the Electoral Law Act (Northern Ireland), 1962(a), hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Electoral Law (Registration and Polling Station Schemes) Regulations (Northern Ireland), 1962.

Service declaration ceasing to be in force

2. Where a service elector transfers from employment under one Government department to employment under another or from being a member of the forces to being a Crown servant, or vice versa, his service declaration and that of his wife (if any), being a person to whom sub-section (2) of section seven of the Electoral Law Act (Northern Ireland), 1962, refers, shall cease to be in force.

Preparation of polling station schemes

3.—(1) In the preparation of polling station schemes under sections fifteen and sixty-five of the Electoral Law Act (Northern Ireland), 1962, electoral officers shall conform to the requirements of this Regulation.

(2) No premises licensed for the sale of intoxicating liquors shall be selected for use as a polling station.

(3) The polling station or stations for any polling district shall, so far as practicable, be situated within the polling district, but the electoral officer may designate for any polling district one or more than one polling station situated in an adjoining polling district (whether or not any such station is also designated as a polling station for the polling district in which it is situate) if he is satisfied that by such designation better facilities for voting by the electors in the first-mentioned polling district will thereby be provided.

(4) Where more than one polling station is designated in any polling district the scheme shall indicate what portion of the polling district each station is intended to serve.

(5) The scheme shall indicate the approximate number of parliamentary electors for whom each station is provided and where the same polling station is to be used by electors from more than one polling district the approximate number of parliamentary electors from each district shall be shown.

(6) Not later than ten days after the publication of the register in the year 1964 and every third year thereafter, the electoral officer shall give public notice, in Form R.V. in the First Schedule, that the draft scheme will be open for inspection at the office of the county or county borough council during ordinary office hours during the seven days succeeding the date of the public notice and, in the case of a county, that the relevant sections thereof will be open for inspection during the like hours and days at the offices of the councils of the boroughs, urban and rural districts contained within the county, and that objections or proposals may be lodged with him in writing in respect of any part of the scheme by any parliamentary or local government elector, or by any group of such electors, during a period of fourteen days from the date of the notice.

(7) The electoral officer shall consider any such objections or proposals made to him in relation to the draft scheme and may, at his discretion, amend the draft scheme accordingly.

(8) Not later than one month after the date of the publication of the register the electoral officer shall submit to the Ministry a copy of the draft scheme as first exhibited, together with particulars of any amendments made therein, and of any objections or proposals submitted to him but not given effect, with his reasons for not giving effect to them.

(9) When a polling station scheme has been finally approved by the Ministry the electoral officer shall within seven days of being notified of the Ministry's approval give public notice thereof in the Form R.X. in the First Schedule. He shall at all times keep a copy of the approved scheme available for inspection at his office and shall permit any interested party to examine it and to copy extracts from it at any time during ordinary office hours and shall also cause a copy of the relevant sections thereof to be kept similarly available for inspection at the offices of each deputy electoral officer.

Forms

4. The forms contained in the First Schedule shall be used for the purposes for which they are expressed to be applicable.

Revocations

5. The Regulations set out in the Second Schedule are hereby revoked to the extent specified in the second column of that Schedule.

Notes

OCCUPIER. The "occupier" is normally the person paying rent for the house or the owner of the house if he lives in it.

RESIDENCE. You should include a person:-

(a) Ordinarily resident who is temporarily away, e.g., on a visit or as a student or who is a patient or inmate in a hospital or institution or who is detained in legal custody; or

(b) who is away on a job unless his absence will be for more than 6 months.

Guests and visitors who ordinarily live elsewhere should not be included but resident domestics or lodgers should be included.

A person's residence is deemed not to be interrupted by the furnished letting of a house-

(a) for a period not exceeding 6 months if he or his spouse expects to be away on a job during that period;

(b) for a period or periods not exceeding in all 4 months in any year.

A person may not be registered for the purposes of an election in respect of more than one residence. If he has more than one residence he must declare the fact to the electoral officer or his agent and must decide which shall be his residence for registration purposes.

A member of the Royal Ulster Constabulary or Ulster Special Constabulary who is away from home on duty is regarded as residing at both addresses but must comply with the foregoing paragraph in regard to his choice of residence.

SERVICE VOTERS. You should not include in the form:-

(a) members of Her Majesty's Forces;

(b) Crown Servants employed outside the United Kingdom; or

(c) the wives of either if they are living outside the United Kingdom to be with their husbands.

he shall be registered by virtue only of the residence qualification or the resident occupier's qualification as the case may be; and in relation to the spouse of any person having the qualifications referred to in paragraph (a) the like restriction shall apply."

2. Where in the case of a claim this notice includes a requirement by the revising officer that the person receiving it appear at the hearing to substantiate the claim, fails to appear at the hearing the revising officer may disallow the claim.

3. Where a person who has given notice of objection fails to appear at the hearing or fails to give or produce evidence in support of the objection the revising officer may strike out the objection.

PARLIAMENTARY ELECTORS

All persons whose names appear in the list appear to be entitled to vote at both Northern Ireland and United Kingdom parliamentary elections *unless* the contrary is indicated by a letter preceding the name. The meaning of the letters is as follows:—

- N means that the elector *can* vote at a Northern Ireland election but *cannot* vote at a United Kingdom election.
- B means that the elector *can* vote at a Northern Ireland election by virtue of a business premises' qualification or as the spouse of a person having such qualification but *cannot* vote at a United Kingdom election.
- I means that the elector *cannot* vote at a Northern Ireland election but *can* vote at a United Kingdom election. If this letter is followed by the letter Y it indicates an elector who is entitled to vote at a United Kingdom election only after 1st October, 19
- L means that the elector has only a local government qualification and *cannot* vote at any parliamentary election in respect of that entry.

A person possessing a service qualification is distinguished by the letter S preceding his name. Generally such persons *can* vote at all parliamentary elections. Where this is *not* the case the letter S is preceded by the letter N or the letters I or IY with the meaning stated above. Merchant seamen who *are* service voters at Northern Ireland elections but are *not* service voters at United Kingdom elections are distinguished by the letters S(N.I.).

LOCAL ELECTORS

The nature of an elector's local government qualification is shown by the letters opposite his name in the column headed "Local Government". Where no such index letters appear opposite an elector's name he has no local government vote. The meaning of the letters is as follows:—

RO Resident occupier's qualification.

ROS Qualification as spouse of resident occupier.

- GO General occupier's qualification.
- CN Company qualification.

ML Qualified by virtue of sub-section (4) of section 4 of the Act of 1962.

S Qualified by virtue of sub-section (5) of section 4 of the Act of 1962.

XS Qualified by virtue of sub-section (6) of section 4 of the Act of 1962.

BL Qualified by virtue of sub-section (7) of section 4 of the Act of 1962.

The names of persons appearing to be qualified in respect of company qualifications appear after the names of persons registered in respect of other qualifications according to the street order of the premises from which company qualifications are derived.
