EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations substitute for the Schedule to the principal regulations (which sets out provisions of the regulations dealing with the collection and recovery of Income Tax under Pay As You Earn as modified to apply for the purpose of graduated contributions) a new Schedule which makes the consequential amendments necessitated by the consolidation in the Income Tax (Employments) Regulations 1962 of the Income Tax provisions; the Regulations in the Schedule are again not numbered consecutively so that those provisions of the Income Tax (Employments) Regulations 1962 applied or adapted retain for graduated contributions purposes the numbers which they bear in the latter regulations. The only amendment of substance is in regulation 34 in the Schedule, corresponding to a similar provision in the Income Tax (Employments) Regulations 1962, which clarifies the powers of the Collector of Taxes to certify for recovery purposes, following an inspection of an employer's records, the amounts of graduated contributions unpaid by him.

The Regulations incorporate the additions made to the Schedule, in respect of seamen's graduated contributions, by the National Insurance (Collection of Graduated Contributions) Amendment Regulations (Northern Ireland), 1961, and those regulations are accordingly revoked.

HEALTH SERVICES

General Scheme: Modification

ORDER, DATED 30TH OCTOBER, 1962, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION 28 OF THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

Whereas section 28(4) of the Health Services Act (Northern Ireland) 1948(a), provides that the Northern Ireland Hospitals Authority (in this Order referred to as "the Authority") may from time to time, after consultation with the Ministry of Health and Local Government (in this Order referred to as "the Ministry"), adopt a new general scheme providing for the modification of the general scheme for the time being in force:

And whereas the Authority has adopted and submitted to the Ministry a new general scheme providing for the modification of the general scheme already adopted by the Authority and approved by the Ministry by Order dated 31st May, 1948(b), as modified by new general schemes adopted by the Authority and approved by the Ministry by Orders dated 31st December,

1948(a), 30th September, 1949(b), 1st January, 1950(c), 11th April, 1951(d), 31st October, 1956(e), 18th September, 1957(f), 21st August, 1958(g), 26th March, 1959(h), 18th December, 1959(i), 3rd February, 1961(i) and 20th March, 1962(k).

And whereas the Ministry thinks fit to approve the new general scheme:

Now, therefore, the Ministry, in exercise of the powers conferred upon it by section 28 of the Health Services Act (Northern Ireland), 1948, and of all other powers so enabling, hereby orders as follows:-

- 1. This Order may be cited as the Health Services (General Scheme Modification) Order (Northern Ireland), 1962.
- 2. The Ministry hereby approves the new general scheme as set out in the Schedule, subject to the following modifications:-
- (1) in paragraph 1, for the words "as from the date hereof" there shall be substituted the words "on and after the 1st day of November, 1962."
- (2) in paragraph 2(i), for the words "as from the 1st day of October, 1962" there shall be substituted the words "on and after the 1st day of November, 1962."
- (3) in paragraph 2(ii), for the words "as from" there shall be substituted the words "on the expiration of."
- (4) in paragraph 3, for the words "as from" there shall be substituted the words "on and after."

SCHEDULE

New General Scheme made under the Provisions of the Health Services Acts (Northern Ireland), 1948-1958

Whereas the Northern Ireland Hospitals Authority (hereinafter called "the Authority") in exercise of the powers conferred on them by Section 28 of the Health Services Act (Northern Ireland), 1948 (hereinafter called "the Act") did on the 13th day of May, 1948, adopt a General Scheme (hereinafter called "the General Scheme"):

And whereas the said General Scheme was approved by the Ministry of Health and Local Government (hereinafter called "the Ministry") by Order made on the 31st day of May, 1948.

And whereas the said General Scheme has from time to time been modified as provided for in the Act:

And whereas the Authority after consultation with the Ministry have decided to adopt the new General Scheme hereinafter set forth:

Now therefore the Authority in exercise of the powers conferred on them by Section 28 of the Act and of all other powers them thereunto enabling do hereby adopt the following new General Scheme providing for the modification of the said General Scheme, that is to say:

- 1. The Mid-Antrim Hospital Management Committee in addition to having the powers and duties already assigned to it, shall, as from the date hereof, manage and control Peter Stott Martin House, Cullybackey, Co. Antrim.
 - 2. The Ulster Hospital Management Committee shall:—
 - (i) In addition to having the powers and duties already assigned to it, as from the 1st day of October, 1962, manage and control the Ulster Hospital, Dundonald, Co. Down.
 - (ii) As from the 17th day of November, 1962, cease to manage and control the premises in which the Ulster Hospital for Children and Women is at present carried on (except the premises at Templemore Avenue, Belfast, now to be known as the Templemore Avenue Hospital).
- 3. The Belfast Hospital Management Committee, in addition to the powers and duties already assigned to it, shall, as from the 18th day of November, 1962, manage and control the premises at Whitehall Parade, Belfast, at present occupied by the Ulster Hospital for Children and Women, now to be known as the Haypark Hospital.
- 4. The General Scheme shall be read and shall operate as modified by this New General Scheme.
