EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations provide as follows:—

- (1) The partial exemption of fire engines from the requirements about overall length is extended to cover new types of fire escapes.
 - (2) Agricultural tractors need not have more than one rear view mirror.
- (3) The device on Diesel engines which facilitates starting (but which produces smoke) is not to be used while the vehicle is moving.
- (4) The minimum permitted overhang of motor cars and heavy motor cars is increased to take account of new trends in vehicle design.
- (5) The Finance Act (N.I.) 1961, now provides that a tractor, the two front wheels of which are less than 18" apart, is to be treated as a three-wheeled vehicle. This makes a previous amendment to the Principal Regulations unnecessary and it is now revoked.

FAMILY ALLOWANCES, NATIONAL INSURANCE AND INDUSTRIAL INJURIES

Commencement Order (Northern Ireland), 1962

Order, dated 13th February, 1962, made by the Minister of Labour and National Insurance under the Family Allowances and National Insurance and Assistance Act (Northern Ireland), 1962.

Whereas it is provided by paragraph 1 of the Third Schedule to the Family Allowances and National Insurance and Assistance Act (Northern Ireland), 1962(a), that the provisions mentioned in that paragraph shall come into force on such date or dates (whether before or after the passing of that Act) as the Minister of Labour and National Insurance may by order appoint:

Now, therefore, I, the Right Honourable Ivan Neill, Minister of Labour and National Insurance for Northern Ireland, hereby make the following Order:

- 1. The date appointed for the coming into force of any provision of the Family Allowances and National Insurance and Assistance Act (Northern Ireland), 1962, specified in the first column of the Schedule shall be the date specified in the second column of that Schedule and set opposite to that provision.
- 2. This Order may be cited as the Family Allowances, National Insurance and Industrial Injuries (Commencement) Order (Northern Ireland), 1962.
