EXPLANATORY NOTE

(This note is not part of the Regulations and does not purport to be a legal interpretation.)

The effect of these Regulations will be to lengthen the weekly period during which netting for fish is prohibited in the Foyle Area from 48 to 72 hours.

The period of the weekly close time prohibition is at present from 6 a.m. on Saturday to 6 a.m. on the following Monday. The new period will be, for the lower part of the Foyle Tideway the 72 hours from 6 a.m. Friday to 6 a.m. Monday and for the remainder of that River system the 72 hours from 6 a.m. Saturday to 6 a.m. Tuesday: the purpose of this staggering of part of the weekly close time is to provide increased opportunities for a larger escapement of spawning fish.

The purpose of this change is to "rest" the stocks of salmon in the Foyle system until such time as runs of normal proportions are re-established. Accordingly, the Regulations permit of reversion to the shorter statutory weekly close time in any season when the run of salmon is shown to the satisfaction of the Commission to be of sufficient strength to warrant the lifting of these added restrictions.

NATIONAL INSURANCE AND INDUSTRIAL INJURIES

Transitional Provisions

REGULATIONS, DATED 8TH MARCH, 1962, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE FAMILY ALLOWANCES AND NATIONAL INSURANCE AND ASSISTANCE ACT (NORTHERN IRELAND), 1962.

The Ministry of Labour and National Insurance, in exercise of powers conferred by paragraph 8 of the Third Schedule to the Family Allowances and National Insurance and Assistance Act (Northern Ireland), 1962(a), and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the National Insurance and Industrial Injuries (Transitional Provisions) Regulations (Northern Ireland), 1962, and shall come into operation on the 3rd April, 1962.
 - (2) In these regulations—

"the Act of 1962" means the Family Allowances and National Insurance and Assistance Act (Northern Ireland), 1962;

"benefit" means benefit under the National Insurance Acts (Northern Ireland), 1946 to 1962, or under the National Insurance (Industrial Injuries) Acts (Northern Ireland), 1946 to 1962;

"child" has the meaning assigned to it by the National Insurance Act (Northern Ireland), 1946(a).

Apprentices ceasing to be children on the coming into force of section 8(b) of the Act of 1962

- 2.—(1) This regulation shall apply in relation to any benefit the right to which or the rate of which depends on a person (hereinafter called "the dependant") being a child in a case where, by virtue of paragraph (b) of section 8 of the Act of 1962 (which paragraph amends the definition of "apprentice" for the purposes of the Family Allowances Act (Northern Ireland), 1945(b)), the dependant ceases to be a child on the coming into force of that paragraph.
- (2) Where, immediately before the date of the coming into force of the said paragraph (b), a person is entitled to any benefit in relation to which this regulation applies and, for a continuous period beginning on that date, that person or any other person would be entitled to any such benefit, or to such benefit at a higher rate, but for the dependant ceasing to be a child by virtue of that paragraph, then, notwithstanding that paragraph, the dependant shall continue to be treated as a child throughout that period for the purposes of that person's or that other person's right to such benefit or to such benefit at a higher rate.
- (3) For the purposes of paragraph (2), a period shall be treated as a continuous period if it would have been such a period but for the occurrence of Sunday or such other day as is prescribed under paragraph (d) of subsection (2) of section 10 of the National Insurance Act (Northern Ireland), 1946.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations provide for the circumstances in which a person shall continue to be treated as a child for the purposes of the right to benefit under the National Insurance Act (Northern Ireland), 1946, and the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946, where otherwise he would in consequence of section 8(b) of the Family Allowances and National Insurance and Assistance Act (Northern Ireland), 1962, cease to be a child for those purposes.
