## EXPLANATORY NOTE

# (This Note is not part of the Order but is intended to indicate its general purport.)

This Order has been made in accordance with the provisions of the Aid to Industry Act (Northern Ireland), 1961, which has superseded the Aid to Industry Act (Northern Ireland), 1953. The principal change is that the contributions which were previously paid to gas and electricity undertakings based on the quantity of coal used to produce the gas and electricity purchased by registered persons and which were passed on to the registered persons by the gas and electricity undertakings, will now be paid direct to those persons as gas and electricity contributions. The procedure for registration and for the submission of claims remains unaltered. It is unnecessary for persons registered under an Order made under the 1953 Act to seek re-registration.

## TRAINING SCHOOLS

#### **Contributions by Local Authorities**

Regulations, dated 22nd March, 1962, made by the Ministry of Home Affairs under sub-section (1) of Section 126 and sub-section (2) of Section 134 of the Children and Young Persons Act (Northern Ireland), 1950.

of Section 134 of the Children and Young Persons Act (Northern Ireland), 1950(a), hereby makes the following Regulations:—

## Citation and commencement

1. These Regulations may be cited as the Training Schools (Contributions by Local Authorities) Regulations (Northern Ireland), 1962, and shall come into operation on the 1st day of April, 1962.

#### *Contributions*

2. The contributions to be made under sub-section (1) of Section 126 of the Children and Young Persons Act (Northern Ireland), 1950, by the local authority named in a training school order to the expenses of the managers of a training school throughout the time in the financial year 1962-63 during which the person to whom the order relates is under the care of the said managers and is not—

- (a) out on licence or under supervision,
- (b) receiving free of charge to the said managers hospital accommodation provided under Part III of the Health Services Act (Northern Ireland), 1948(b), having been receiving such accommodation for a continuous period of not less than fourteen days, or
- (c) a person who under sub-section (1) of Section 110 of the Children and Young Persons Act (Northern Ireland), 1950 (which relates to escapes from training schools, failure to return to training schools after temporary leave of absence and other like matters), is for the time being liable to be apprehended without warrant and has been so liable for a continuous period of not less than fourteen days,

shall be at the rate of thirty-four shillings and fourpence a week for Shamrock Lodge Training School and at the rate of ninety-five shillings and threepence a week for all other training schools.

## EXPLANATORY NOTE

(This Note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations prescribe the contribution to be made by the local authority named in a training school order towards the expenses of the managers of the school in respect of the person to whom the order relates during the time within the financial year 1962-63 when that person is under the care of those managers. They differ from the Regulations made in respect of the financial year 1961-62 in that the rate of contribution for Shamrock Lodge is increased to £1 14s. 4d. and the rate for all other training schools is increased to £4 15s. 3d. a week, and in providing that no contribution is payable during any part of a period, after the first fortnight thereof, when the person to whom the order relates is in hospital free of charge to the managers of the school or is unlawfully absent from the school.
