Regulations The Nursery Schools Regulations (Northern Ireland) 1948

The Nursery Classes in Primary Schools Regulations (Northern Ireland) 1956(a)

Extent of Amendment.

In Regulation 6(1), after the words "under the Act" there shall be added "(including the requirements set out in these Regulations)". In Regula-tion 11(2), for the words "under these Regulations" there shall be substituted "under the Act". For Regulation 19 there shall be substituted the following Regulation:—

"19. The Ministry may pay grant in respect of a voluntary nursery school equal to sixty-five per cent. of the approved expenditure incurred by the school authorities in the employment of nursery assistants."

For Regulation 8(2) there shall be substituted the following:-

"(2) Pupils enrolled in a nursery class shall be counted for the purpose of calculating a principal's or vice-principal's allowance and of determining the number of graded posts in a school under the Salary Regulations."

For Regulation 12 there shall be substituted the following Regulation:-

"12. The Ministry may pay grant in respect of a nursery class in a voluntary school equal to sixty-five per cent. of the expenditure incurred by the school authorities on the employment of nursery assistants."

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations introduce retrospectively from 1st April 1963 revised scales of salaries and allowances for teachers in primary schools, intermediate schools (other than technical intermediate schools), grammar schools and special schools.

Grammar Schools: Grant Conditions

REGULATIONS, DATED 10TH MAY 1963, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1962, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

Education

The Ministry of Education (hereinafter called "the Ministry") in pursuance of the powers vested in it by Sections 104 and 112 of the Éducation Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance, hereby makes the following Regulations : ---

1.--(1) These Regulations may be cited as the Grammar Schools (Grant Conditions) Amending Regulations No. 2 (Northern Ireland) 1963.

(2) These Regulations shall be deemed to have come into operation on 1st April 1963.

2. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations 1956(b).

3. The following paragraph is hereby substituted for paragraph 2 of the Third Schedule to the existing Regulations which provides for the payment of salary grant:-

"2. Subject to the provisions of Regulations 25 and 40 salary grant shall be payable in respect of each teacher appointed to the authorised staff of the school and shall be at an annual rate equal to two-thirds of the amount by which the annual rate of salary (including the principal's allowance, vice-principal's allowance, graded allowance or allowance for second master or second mistress) payable to the teacher under the Regulations exceeds the rate of £525 per annum:

Provided that-

In respect of any period of absence, owing to illness, in respect of which a teacher is paid half salary, the salary grant payable by the Ministry in respect of him for the period shall be half the salary grant that would normally be payable."

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations provide that the salary grant will be two-thirds of the amount by which the salary payable to a teacher on the authorised staff of a voluntary grammar school exceeds the rate of £525 per annum as from 1st April 1963.
