#### **EXPLANATORY NOTE**

(This note is not part of the Regulations and does not purport to be a legal interpretation.)

These Regulations amend the Foyle Area (Rivers Faughan and Roe Angling) Regulations 1959 by permitting fly fishing at night time until July 15th each season, and by prohibiting the use of floats in bait fishing. Fishing fifty yards downstream of Given's Weir in the townland of Terrydremont is also prohibited.

# FOYLE FISHERIES

# Foyle Area (Prevention of Pollution) Regulations 1963

REGULATIONS, DATED 30TH APRIL 1963, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR LANDS OF THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISHERIES ACT 1952 AND OF THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission hereinafter referred to as "the Commission" in exercise of its powers under Section 13 of the Foyle Fisheries Act 1952 and Section 13 of the Foyle Fisheries Act (Northern Ireland) 1952 hereby makes the following regulations:

- 1. These regulations may be cited as the Foyle Area (Prevention of Pollution) Regulations 1963.
- 2. These regulations shall apply to all discharges of effluent from sand or gravel washing plants within the Foyle Area and shall come into effect on 13th May 1963.
- 3. Subject to these regulations no person shall without the consent of the Commission discharge on or after 1st July 1963 any effluent from a sand or gravel washing plant into a river in the Foyle Area.
- 4. An application to the Commission for its consent under these regulations shall state:
  - (a) The maximum quantity of the effluent which it is proposed to discharge during any one day.
  - (b) The highest rate at which it is proposed to discharge the effluent.
  - (c) The exact location of the proposed plant and outfall of the effluent.
  - (d) The proposed method of disposal or treatment of the effluent.
- 5. On application for consent under Article 4 of these regulations the Commission may grant its consent subject to such conditions as it may impose, which conditions may include conditions as to:

- (a) The composition, volume, or rate of discharge of effluent from the land or premises to which the application relates.
- (b) The provision of facilities for taking samples of what is passing from the land or premises to the river.
- 6. Subject to these regulations where on or after 1st July 1963 a discharge is made into a river in the Foyle area without the consent of the Commission, the Commission may give to the person making the discharge a notice specifying any such conditions as it might have imposed on an application for its consent for making the discharge. Where such notice has been given the Commission shall be deemed to have given its consent under Article 5, subject to the conditions specified in the notice.
- 7. No conditions imposed under these regulations shall take effect until the expiration of a period of one month beginning with the giving of consent under Article 5, or as the case may be, the giving of a notice under Article 6.
- 8. The Commission may revoke or vary any condition imposed or deemed to be imposed by it under these regulations. Such revocation or variation of conditions shall be notified in writing to the owner of the plant concerned, provided that no variation of conditions shall take effect until the expiration of a period of one month from the date of the notice.
- 9. Any person aggrieved by the terms of a consent made under these regulations may appeal to the Minister or the Ministry within one month of the issue of such consent, and the Minister or the Ministry may direct the Commission to amend the conditions of the consent.
- 10. No person shall cause or knowingly permit to enter any river from land or premises in relation to which conditions have been imposed under these regulations and are for the time being in force any effluent not complying with those conditions.

# WAGES COUNCILS

# Wages Regulation (Rope, Twine and Net)

Order, dated 16th May, 1963, made by the Ministry of Labour and National Insurance under the Wages Councils Act (Northern Ireland) 1945.

The Ministry of Labour and National Insurance, in exercise of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland) 1945(a), hereby makes the following Order to give effect to wages regulation proposals received from the Rope, Twine and Net Wages Council (Northern Ireland):—

#### Citation

1. This Order may be cited as the Rope, Twine and Net Wages Regulation (Amendment) Order (Northern Ireland) 1963.

#### Commencement

2. The wages regulation proposals set out in the schedule shall come into operation on the specified date and on the day immediately preceding that date the Rope, Twine and Net Wages Regulation (Amendment) Order (Northern Ireland) 1962(b) shall cease to have effect.

#### *Interpretation*

3. In this Order the expression "the specified date" means the 27th day of May, 1963, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.
