2. for paragraph 3 there were substituted the following paragraph-

"CALCULATION OF HOURLY RATES

Paragraph 3.

The general minimum time rates specified in paragraph 1 and in subparagraph (a) of paragraph 2 are weekly rates based on a week of 42 hours.

For the purpose of calculating the hourly minimum rate the respective weekly rates should be divided by 42."

3. for paragraph 4 there were substituted the following paragraph—

"NORMAL WORKING DAY

Paragraph 4.

The normal working week shall consist of-

- (a) in the case of a worker who is normally | 5 days of 7¹/₄ hours each and required to work on 6 days of the week | 1 day of 3¹/₄ hours.
- (b) in the case of a worker who is normally | 4 days of 8½ hours each and required to work on 5 days of the week | 1 day of 8 hours."

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order, which comes into operation on 10th September, 1963, amends the Road Haulage Wages Regulation Order (Northern Ireland) 1961 (Order N.I.R.H. (26)), as amended by the Road Haulage Wages Regulation (Amendment) Order (Northern Ireland) 1962 (Order N.I.R.H. (28)), by increasing the statutory minimum remuneration fixed by those Orders. Order N.I.R.H. (28) is revoked.

LOCAL GOVERNMENT

Travelling and Subsistence Allowances to Members

REGULATIONS, DATED 2ND SEPTEMBER, 1963, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE PUBLIC HEALTH AND LOCAL GOVERNMENT (ADMINISTRATIVE PROVISIONS) ACT (NORTHERN IRELAND) 1946.

The Ministry of Health and Local Government, in exercise of the powers conferred upon it by sections 27, 27B, 27C and 28 of the Public Health and Local Government (Administrative Provisions) Act (Northern Ireland) 1946(a) hereby makes the following regulations:—

1. These Regulations may be cited as the Local Government (Allowances to Members) (Amendment) Regulations (Northern Ireland) 1963, and shall come into operation on 2nd September, 1963.

2. The Local Government (Allowances to Members) Regulations (Northern Ireland) 1955(a) shall be amended as follows:—

For paragraph 1(1) of the Second Schedule there shall be substituted—

- "(1) The rate of subsistence allowance shall not exceed—
- (a) in the case of an absence, not involving an absence overnight, from the usual place of residence—
 - (i) of more than five but not more than ten hours, 6s.;
 - (ii) of more than ten hours, 13s.;
- (b) in the case of an absence overnight from the usual place of residence—
 - (i) in Ireland, 47s.;
 - (ii) in Great Britain, 63s."
