- (3) In Form E there shall be substituted for the words "Department for Affairs of Mental Patients (Northern Ireland)" the words "The Department for the Affairs of Patients".
- (4) In Form G there shall be substituted for the words "Department for Affairs of Mental Patients (Northern Ireland)" the words "The Department for the Affairs of Patients".
- (5) In paragraph 2 of Form K (Petition under section 103 of the Act) there shall be substituted for the word "Affidavits" in italics the word "Certificates" in italics.
- (6) In Form L there shall be substituted for the words "Department for Affairs of Mental Patients (Northern Ireland)" where they appear in the fourth paragraph thereof the words "The Department for the Affairs of Patients".
- (7) Form O shall be deleted.

1. The currency of any Ulster Savings Certificates issued on or after the 1st October, 1933, and before the 22nd November, 1939 (in this Regulation referred to as a "certificate of the Fifth Issue"), shall be prolonged until such date as the Ministry of Finance may by regulations hereafter determine.

2. Interest shall be added after the thirtieth anniversary of the date of purchase at the rate of twopence-halfpenny in respect of each unit certificate of the Fifth Issue for each completed period of three months.

3. These Regulations may be cited as the Ulster Savings Certificates (Fifth Issue) Regulations 1963, and shall be construed as one with the Ulster Savings Certificates Regulations 1962.
