AGRICULTURAL DEVELOPMENT LOANS

Farm Structures

Scheme, dated seventeenth day of October, 1963, made by the Ministry of Agriculture under Section 1 of the Development Loans Act (Northern Ireland) 1945(a).

The Ministry of Agriculture in exercise of the powers conferred on it by Section 1(1) of the Development Loans Act (Northern Ireland) 1945, and with the approval of the Ministry of Finance, hereby makes the following Scheme:

Citation

1. This Scheme may be cited as the Agricultural Development Loans (Farm Structures) Scheme (Northern Ireland) 1963.

Revocation

2. The Agricultural Development Loans (Farm Structures) Scheme (Northern Ireland) 1962(b) is hereby revoked.

Purpose and Conditions

3. The Ministry of Agriculture (hereinafter referred to as "the Ministry") may make loans for the purchase, erection, reconstruction or improvement of farm structures and for land improvements to the owners or occupiers of agricultural land.

General

4.—(1) The amount of the loan shall not exceed the approved cost to the borrower after allowing for any grant or subsidy payable.

(2) The borrower shall give such security as may be approved by the Ministry.

(3) Repayment shall be made on such terms and in such manner as may be approved by the Ministry over a period not exceeding ten years.

(4) Repayment of principal may be deferred in approved cases for a period not exceeding three years where the amount of the loan exceeds one thousand pounds.

(5) The amount of any loan shall not exceed two thousand pounds except with the special sanction of the Ministry of Finance.

(6) The legal costs of the Ministry and any outlay incurred in connection with securing a loan shall be paid by the borrower.

EXPLANATORY NOTE

(This note is not part of the Scheme but is intended to indicate its general purport.)

This Scheme revokes the Scheme hitherto in force for the making of loans for the purchase, erection, reconstruction or improvement of farm structures and for land improvements. It re-enacts the principal provisions but extends the scope of the Scheme to cover the making of loans to occupiers of agricultural land and modifies the period of repayment.

ORDER, DATED 23RD OCTOBER, 1963, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 23(4) OF THE ROAD TRAFFIC ACT (NORTHERN IRELAND) 1955.

The Ministry of Home Affairs in exercise of the powers conferred on it by section 23(4) of the Road Traffic Act (Northern Ireland) 1955(a) (hereinafter referred to as "the Act"), and of all other powers enabling it in that behalf, hereby orders and directs as follows:

Citation and commencement.

1. This Order may be cited as the Roads (Speed Limit) (No. 4) Order (Northern Ireland) 1963 and shall come into operation on 1st December, 1963.

Revocation of Previous Directions

2. The directions contained in the Roads (Speed Limit) Order (Northern Ireland) 1956(b), and the Roads (Speed Limit) (No. 3) Order (Northern Ireland) 1962(c) relative to the lengths of road specified in the First Schedule to this Order are hereby revoked.
