ELECTIONS AND FRANCHISE**Registration Expenses**

REGULATIONS, DATED 19TH DECEMBER, 1963, MADE BY THE MINISTRY OF HOME AFFAIRS WITH THE CONCURRENCE OF THE MINISTRY OF FINANCE UNDER SECTION 21(5) OF THE ELECTORAL LAW ACT (NORTHERN IRELAND) 1962.

The Ministry of Home Affairs in exercise of the powers conferred upon it by section 21(5) of the Electoral Law Act (Northern Ireland) 1962(a) and of every other power it thereunto enabling and with the concurrence of the Ministry of Finance hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Electoral (Registration Expenses) Regulations (Northern Ireland) 1963.

Scale of Registration Expenses

2. The scales of remuneration of officers and expenses set out in the Schedule will apply to the register of electors published under section 28 of the Electoral Law Act (Northern Ireland) 1962 in the year 1963.

3. In a County, allowance for all expenditure, including the remuneration of assistant electoral officers, of an electoral officer other than that specially provided for elsewhere in the scale:—

Actual and necessary expenditure not exceeding the combined produce of the rates set out at (a) and (b) below:

- (a) for so much of the register as relates to boroughs, including the County Borough of Londonderry, and urban districts, at the rate of 45/6 per 100 electors;
- (b) for so much of the register as relates to rural districts at the rate of 56/3 per 100 electors.

4. In the County Borough of Belfast, allowance for all expenditure of the electoral officer other than that specially provided for elsewhere in the scale:—

Actual and necessary expenditure not exceeding the rate of 30/6 per 100 electors.

5. Remuneration and personal expenses of revising officers and their assistants:—

(a) Remuneration payable in respect of each day of sitting:

Clerk of the Crown and Peace	£7 15 —

- (b) Personal expenses—such personal out-of-pocket expenses as are necessarily incurred by revising officers or their assistants in dealing with claims and objections, including travelling expenses and subsistence allowances, at the rates appropriate to Class A officers of the Northern Ireland Civil Service.

6. Every electoral officer shall be allowed as and for out-of-pocket expenses the actual and necessary cost of any:—

Stationery and miscellaneous local printing

Postages

Charge by H.M. Stationery Office for centrally-printed forms

Charge by H.M. Stationery Office for printing lists and register

Miscellaneous out-of-pocket expenses not elsewhere specified

ROYAL ULSTER CONSTABULARY

Rent Allowances and Compensatory Grant

ORDER, DATED 31ST DECEMBER, 1963, MADE BY THE MINISTER OF HOME AFFAIRS WITH THE CONCURRENCE OF THE MINISTER OF FINANCE UNDER THE CONSTABULARY AND POLICE (IRELAND) ACT 1919 AS APPLIED BY THE CONSTABULARY ACT (NORTHERN IRELAND) 1922.

I, the Right Honourable William Craig, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by section two of the Constabulary Act (Northern Ireland) 1922(a) and by sub-section (1) of section four of the Constabulary and Police (Ireland) Act 1919(b), as applied by the said Act of 1922, and of all other powers enabling me in that behalf and with the concurrence of the Minister of Finance, do hereby order as follows:—

Citation

1. This Order may be cited as the Royal Ulster Constabulary Allowances (Rent and Compensatory Grant) Order 1963, and shall have effect from 1st November, 1963.

Definitions

2. In this Order the following expressions shall have the meanings hereby respectively assigned to them:—

“Family” means the member’s wife and/or any child of his under the age of sixteen years.

“The Force” means the Royal Ulster Constabulary.

“Member” means a member, including a woman member, of the Force.

“Ministry” means the Ministry of Home Affairs.

“Owned” means owned by the member or his wife.

“Rent” means the rent actually and necessarily incurred and paid by the member or his wife.

Revocation

3. The Royal Ulster Constabulary Allowances (Rent and Compensatory Grant) Order 1961(c) is hereby revoked.

Rent Allowance

4.—(1) A member shall be entitled to ordinary rent allowance in respect of the accommodation—

(a) of himself, or
