## Handicapped Pupils and Special Schools

REGULATIONS, DATED 14TH MARCH, 1963, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1962, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education, hereinafter referred to as "the Ministry", in pursuance of the powers vested in it by Sections 84 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Handicapped Pupils and Special Schools Amending Regulations (Northern Ireland) 1963.

(2) These Regulations shall come into operation on 1st April, 1963.

2. The existing Regulations hereby amended are the Handicapped Pupils and Special Schools Regulations (Northern Ireland) 1957(b).

3. There shall be inserted after Regulation 24 of the existing Regulations the following Regulation:—

"24A. A teacher shall not be employed before he attains the age of 20 years or after the 31st July next following the date on which he attains the age of 65 years, except for limited periods in cases where there are special circumstances and the Ministry so approves."

## EXPLANATORY NOTE

*(This note is not part of the Regulations, but is intended to indicate their general purport.)*

These Regulations provide that, except in special circumstances, a teacher shall not be employed in a special school before attaining the age of twenty or after 31st July next following the date on which he attains the age of sixty-five.

## DEVELOPMENT OF TOURIST TRAFFIC

## Hotel Grants

REGULATIONS\*, DATED 12TH FEBRUARY, 1963, MADE BY THE MINISTRY OF COMMERCE UNDER SECTION 9 OF THE DEVELOPMENT OF TOURIST TRAFFIC (AMENDMENT) ACT (NORTHERN IRELAND) 1963.

The Ministry of Commerce (in these Regulations referred to as "the Ministry") in exercise of the powers conferred upon it by Section 9 of the Development of Tourist Traffic (Amendment) Act (Northern Ireland) 1963 (in these Regulations referred to as "the Act") and of all other powers enabling it in that behalf hereby makes the following Regulations:

1.—(1) These Regulations may be cited as the Hotel Grants Regulations (Northern Ireland) 1963.

(2) In these Regulations "visitors" include travellers, sojourners or other guests paying for lodging for one or more nights.

2. Section 6 of the Act (under which the Ministry may make grants for hotels, guest houses and boarding houses) shall apply to premises or buildings which the Ministry is satisfied will, after the completion of the relevant works, comply with the following conditions:

(a) The premises or buildings shall be constructed or adapted for the accommodation of visitors.

(b) Not less than three-quarters of the bedrooms provided in the premises or buildings for the accommodation of visitors shall have attached thereto a separate bath or shower or shall be otherwise equipped with a supply of running hot and cold water.
