Teachers' Salariès (Compensation Allowances)

REGULATIONS, DATED 8TH MAY 1963, MADE BY THE MINISTRY OF EDUCATION AFTER CONSULTATION WITH THE MINISTRY OF FINANCE UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1962.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Teachers' Salaries (Compensation Allowances) Amending Regulations (Northern Ireland) 1963.
- (2) These Regulations shall be deemed to have come into operation on 26th February 1963.
- 2. The existing Regulations hereby amended are the Teachers' Salaries (Compensation Allowances) Regulations (Northern Ireland) 1961(b).
- 3. For sub-paragraph (d) of paragraph (2) of Regulation 5 of the existing Regulations there shall be substituted the following sub-paragraph—

"(d) he had reached the age of 50 years—any period of service not later than 31st July next following the date on which the teacher attains the age of 65 years."

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

The existing Regulations provide for the payment of compensation allowances to certain principals or vice-principals of grant-aided schools whose principals' or vice-principals' allowances are discontinued or reduced as a result of the transfer of pupils from their schools. If a teacher has reached the age of 50 on the appropriate date his right to compensation under the existing Regulations extends to the date on which he is deemed to attain the age of 65 under the Teachers (Superannuation) Act (Northern Ireland) 1950.

These amending Regulations substitute a provision that the teacher shall be entitled to compensation until 31st July after he attains the age of 65.

REGULATIONS*, DATED 24TH APRIL, 1963, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE FAMILY ALLOWANCES AND NATIONAL INSURANCE ACT (NORTHERN IRELAND) 1956.

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance, in exercise of powers conferred by section 4(1) of the Family Allowances and National Insurance Act (Northern Ireland) 1956(a), and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the National Insurance (Earnings) Regulations (Northern Ireland) 1963, and shall come into operation on 27th May, 1963.
 - (2) In these regulations—

"the Act" means the National Insurance Act (Northern Ireland) 1946(b).
