Teachers' Salaries

REGULATIONS, DATED 10TH MAY 1963, MADE BY THE MINISTRY OF EDUCATION AFTER CONSULTATION WITH AND WITH THE APPROVAL OF THE MINISTRY OF FINANCE UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1962.

The Ministry of Education, in pursuance of the powers vested in it by Sections 83, 104 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf and after consultation with and with the approval of the Ministry of Finance hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Teachers' Salaries Amending Regulations (Northern Ireland) 1963.

(2) These Regulations shall be deemed to have come into operation on 1st April 1963.

2. The existing Regulations hereby amended are the Teachers' Salaries Regulations (Northern Ireland) 1961(b).

3. After Regulation 7 of the existing Regulations there shall be added :

"7A. For the purposes of these Regulations there shall be deemed to be an increment between the first and second points of Scale I."

4. For Regulation 13 of the existing Regulations there shall be substituted—

"13.—(1) A vice-principal shall be appointed in a primary, intermediate or grammar school with a points score exceeding 200, and a special school with a points score exceeding 180.

(2) A vice-principal shall be appointed in a primary school with a points score exceeding 100 but not exceeding 200 if there were included in the enrolment on the basis of which the points score was determined both pupils whose age was such that by 31st March next following the date by reference to the enrolment on which the points score was determined they would not attain the age of eight years and pupils whose age was such that by the said 31st March they would have attained that age.

(3) Subject to the provisions of paragraph (2), in a primary, intermediate or grammar school with a points score exceeding 164 but not exceeding 200, and a special school with a points score exceeding 139 but not exceeding 180, a vice-principal may be appointed if the Ministry so approves.

(4) In addition to his salary under these Regulations a vice-principal shall receive a vice-principal's allowance determined by reference to the points score of the school in accordance with Schedule IV or Schedule V as the case may be.

(5) For the purposes of paragraph (2) the points score taken into account in determining whether a school has a points score exceeding 100 shall

be that which the school would have if all pupils in the school at any relevant time were under 13 years of age."

5.—(1) Until 31st July 1963, Regulation 15 of and Schedules VI and VII to the existing Regulations shall have effect subject to the provisions of this Regulation.

(2) Unless the Ministry in any particular case otherwise determines, the number of graded allowances payable in any school and the grade of those allowances shall be those which were in existence in the school on 31st March 1963.

(3) The value of each graded allowance to which paragraph (2) refers shall be as follows-

(4) The maximum graded allowance payable to a teacher shall not exceed---

- (a) in a primary or special school £180 £385 . . .
- (b) in an intermediate school ...
- (c) in any school—the allowance payable to the vice-principal of the school.

(5) In any special school to which Regulation 15(6) of the existing Regulations applies, the maximum aggregate value of graded allowances appropriate to the school for the purposes of this Regulation shall be the maximum aggregate value of graded allowances appropriate to the school on 31st March 1963, increased by 10%.

(6) This Regulation shall cease to have effect on 31st July 1963.

6. In Regulation 18 of the existing Regulations—

- (a) in sub-paragraph (1)(b) for the words "an allowance of £200" shall be substituted "an allowance of £220";
- (b) in sub-paragraph (1)(c) for the words "an allowance of £100" shall be substituted "an allowance of £120";
- (c) in sub-paragraph (2)(c) for the words "and £50 successively" shall be substituted "and £60 successively".

7. In Regulation 25(2) of the existing Regulations, for the reference to the sum of £355 shall be substituted a reference to the sum of £380.

8. In Regulation 29(2) of the existing Regulations, for the reference to the sum of £575 shall be substituted a reference to the sum of £610.

9. In Regulation 31 of the existing Regulations, for the words "11s. 0d. per hour" shall be substituted "11s, 9d. per hour",

10. After Regulation 34 of the existing Regulations there shall be inserted the following Regulation:—

"Payment of Salaries

35.—(1) Subject to the deduction of any sums properly deductible therefrom and to the provisions of paragraph (2), the Ministry shall pay to teachers appointed to primary, intermediate and special schools in accordance with the Ministry's Regulations the salaries and allowances to which they are entitled under these Regulations and any other Regulations applicable thereto.

(2) This Regulation does not apply to salaries and allowances paid by a local education authority in respect of which grant is payable under Section 104(1)(b) of the Act.

(3) In this Regulation "teachers" includes unqualified teachers and part-time teachers."

11. The Schedules set out in Appendix A to these Regulations shall be substituted for the Schedules in the existing Regulations which bear the same respective numbers.

12.—(1) The Regulations set out in Part 1 of Appendix B are revoked to the extent indicated therein.

(2) The Regulations set out in Part 2 of Appendix B are amended to the extent indicated therein.

13. A teacher in recognised teaching service on 31st March 1963 shall not receive by reason of the operation of these Regulations a lesser rate of salary than he received under the Regulations in force on that date.

For Regulation 12 there shall be substituted the following Regulation:-

"12. The Ministry may pay grant in respect of a nursery class in a voluntary school equal to sixty-five per cent. of the expenditure incurred by the school authorities on the employment of nursery assistants."

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations introduce retrospectively from 1st April 1963 revised scales of salaries and allowances for teachers in primary schools, intermediate schools (other than technical intermediate schools), grammar schools and special schools.
