Notice of Industrial Diseases.

ORDER, DATED 3RD JULY, 1964, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER SECTION 70 OF THE FACTORIES ACT (NORTHERN IRELAND) 1938.

The Ministry of Labour and National Insurance for Northern Ireland in exercise of powers conferred by section 70(3) of the Factories Act (Northern Ireland) 1938(a) and of all other powers in that behalf, hereby makes the following Order:

1.—(1) This Order may be cited as the Notice of Industrial Diseases Order (Northern Ireland) 1964, and shall come into operation on the 1st day of October, 1964.

(2) So much of the Factories (Forms and Particulars) Order (Northern Ireland) 1950(b) as deals with Form N.I.41 is hereby revoked.

2. The written notice of cases of certain industrial diseases required to be given under section 70(3) and (4) of the Factories Act (Northern Ireland) 1938 shall be in the form set out in the Schedule to this Order and shall be accompanied by the particulars therein specified.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order prescribes the form of written notice required by section 70(3) and (4) of the Factories Act (Northern Ireland) 1938 to be sent to the Chief Inspector of Factories and, except in certain cases, to the appointed factory doctor, of every case of certain industrial diseases occurring in a factory and in certain other premises or places to which the provisions of section 70 of the Act apply.

The form prescribed by this Order is in substitution for that prescribed by the Order of the Ministry of Labour and National Insurance dated 7th June, 1950.
