

- (1) (a) the form in which application for a potato shipping licence may be made;
  - (b) the form of a potato shipping licence; and
  - (c) the fees that shall accompany an application for a potato shipping licence or the renewal of a potato shipping licence;
2. (a) standards of quality, grading, packing and labelling for potatoes for shipment from Northern Ireland;
  - (b) standards of grading and quality for ware potatoes sold in Northern Ireland;
  - (c) standards of quality for seed potatoes sold in Northern Ireland;
  - (d) that potatoes intended for sale in Northern Ireland inspected by request are to be labelled with the name and address of the packer;
3. fees for each inspection of potatoes intended for shipment under licence or under permit or of potatoes inspected by request.

**ULSTER SAVINGS CERTIFICATES**

REGULATIONS, DATED 4TH AUGUST, 1964, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 15(1) OF THE EXCHEQUER AND FINANCIAL PROVISIONS ACT (NORTHERN IRELAND) 1950.

The Ministry of Finance in exercise of the powers conferred upon it by Section 15(1) of the Exchequer and Financial Provisions Act (Northern Ireland) 1950(a) and of all other powers enabling it in that behalf hereby makes the following Regulations:

1. Regulation 11(4) of the Ulster Savings Certificates Regulations 1962(b) shall be amended by the omission therefrom of the words "and on production of the relevant Court Orders (if any)".

2. These Regulations may be cited as the Ulster Savings Certificates (Amendment No. 2) Regulations 1964 and shall be construed as one with the Ulster Savings Certificates Regulations 1962 to 1964, and those Regulations and these Regulations may hereafter be cited together as the Ulster Savings Certificates Regulations 1962 to 1964.

## EXPLANATORY NOTE

*(This note is not part of these Regulations, but is intended to indicate their general purport.)*

These Regulations abolish the requirement for the production of the relevant Court Order on application being made to the Ministry of Finance for repayment of Ulster Savings Certificates registered in the joint names of a County Court Judge and a Clerk of the Crown and Peace or in the sole name of the Accountant General of the Supreme Court of Judicature of Northern Ireland.

## WAGES COUNCILS

**Wages Regulation (Sugar Confectionery and Food Preserving)**

ORDER, DATED 7TH AUGUST, 1964, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE WAGES COUNCILS ACT (NORTHERN IRELAND) 1945.

The Ministry of Labour and National Insurance, in exercise of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland) 1945(a), hereby makes the following Order to give effect to wages regulation proposals received from the Sugar Confectionery and Food Preserving Wages Council (Northern Ireland):—

*Citation*

1. This Order may be cited as the Sugar Confectionery and Food Preserving Wages Regulation Order (Northern Ireland) 1964.

*Commencement*

2. The wages regulation proposals set out in the Schedule shall come into operation on the specified date and on the day immediately preceding that date the Sugar Confectionery and Food Preserving Wages Regulation Order (Northern Ireland) 1962(b) and the Sugar Confectionery and Food Preserving Wages Regulation (Amendment) Order (Northern Ireland) 1963(c) shall cease to have effect.

*Interpretation*

3. In this Order the expression "the specified date" means the 18th day of August, 1964, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.
