ALLOCATION OF PENSION

RULES, DATED 10TH SEPTEMBER, 1964, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 33 OF THE SUPERANNUATION ACT (NORTHERN IRELAND) 1949 AND SECTION 33 OF THE SUPERANNUATION ACT 1949. AS APPLIED TO EXISTING IRISH OFFICERS WITHIN THE MEANING OF THE GOVERNMENT OF IRELAND ACT 1920 BY THE SUPERANNUATION ACT (APPLICATION TO EXISTING IRISH Officers) Order 1949.

The Ministry of Finance in exercise of the powers conferred on it by section 33 of the Superannuation Act (Northern Ireland) 1949(a) and section 33 of the Superannuation Act 1949(b), as applied to existing Irish Officers within the meaning of the Government of Ireland Act 1920(c) by the Superannuation Act (Application to Existing Irish Officers) Order 1949(d), and of all other powers enabling it in that behalf, hereby makes the following rules:—

Citation and Commencement

1. These rules may be cited as the Superannuation (Allocation of Pension) (Amendment) (No. 2) Rules (Northern Ireland) 1964, and shall come into operation on the 1st day of October, 1964.

Amendment of the Superannuation (Allocation of Pension) Rules (Northern Ireland) 1951

- 2. The Superannuation (Allocation of Pension) Rules (Northern Ireland) 1951(e) shall be amended by:—
 - (a) deleting rule 8(1)(c) thereof; and
 - (b) substituting references to the sum of £6 6s. 0d. for the references to the sum of £3 3s. 0d. in rule 12(9) thereof.

EXPLANATORY NOTE

(This note is not part of the rules but is intended to indicate their general purport.)

The Superannuation (Allocation of Pension) Rules (Northern Ireland) 1951 under which a retired civil servant under the age of 70 who has married subsequent to retirement may allcoate part of his pension in favour of his wife, contained a restriction as to the minimum amount that could be allocated. The amending rules now made remove that restriction.

The amending rules also provide that the maximum fee payable in respect of an examination by a Medical Board shall be increased from £3 3s. 0d. to £6 6s. 0d.
