

so far as is material for the purposes of the accounts delivered under the Act, of the state of the company's affairs at the date thereof:

Provided that this paragraph shall not apply where the first accounts delivered under the Act were audited by a person who audited the balance sheet comprised in the last such accounts.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations, which are made under the Protection of Depositors Act (Northern Ireland) 1964, prescribe the information to be contained in or annexed to audited and interim accounts delivered by companies under that Act. The Regulations apply, subject to certain exceptions and modifications, the principal provisions of the Companies Act (Northern Ireland) 1960 relating to companies' accounts. The Regulations also specify in Part 1 of Schedule 2 the additional information which must be given by all companies delivering accounts under the Act, and in Part 2 of that Schedule, the further special information which must be given by certain property companies.

COUNTY COURTS ACT (NORTHERN IRELAND) 1959

County Courts—County of Down

ORDER, DATED 9TH OCTOBER, 1964, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTIONS 2 AND 4 OF THE COUNTY COURTS ACT (NORTHERN IRELAND) 1959.

I, the Right Honourable Robert William Brian McConnell, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by sections 2 and 4 of the County Courts Act (Northern Ireland) 1959(a) do hereby order as follows:—

Citation and commencement

1. This Order may be cited as the County Courts Times of Sittings (County Down) Order (Northern Ireland) 1964 and shall come into operation on the 1st day of January, 1965.

Times of sittings and nature of business to be transacted

2. The ordinary sittings of the county courts for the divisions and the places in those divisions set out in the first column of the Schedule shall be held within the periods shown in the second column of that Schedule and the nature of the business to be transacted by such courts shall be as specified in the third column of that Schedule.

Revocation

3. The County Courts Times of Sittings (County Down) Order (Northern Ireland) 1963(a) is hereby revoked.
