**LANDS TRIBUNAL AND COMPENSATION ACT****Appointed Day**

ORDER, DATED 28TH OCTOBER, 1964, MADE BY THE MINISTER OF FINANCE UNDER SECTION 23(2) OF THE LANDS TRIBUNAL AND COMPENSATION ACT (NORTHERN IRELAND) 1964.

I, the Right Honourable Ivan Neill, Minister of Finance, in exercise of the powers conferred on me by Section 23(2) of the Lands Tribunal and Compensation Act (Northern Ireland) 1964(a) do hereby order as follows:—

1. This Order may be cited as the Lands Tribunal and Compensation Act (Appointed Day) Order (Northern Ireland) 1964.

2. Sections 1 to 5, 7, 9, 11 and 12 of the Lands Tribunal and Compensation Act (Northern Ireland) 1964 shall come into operation on 29th October, 1964.

**AGRICULTURE****Marketing of Potatoes**

REGULATIONS, DATED 23RD OCTOBER, 1964, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 11 OF THE MARKETING OF POTATOES ACT (NORTHERN IRELAND) 1964.

The Ministry of Agriculture in exercise of the powers conferred on it by section 11 of the Marketing of Potatoes Act (Northern Ireland) 1964(b) and of every other power enabling it in that behalf, and with the approval, so far as it is required by the said Act, of the Ministry of Finance, hereby makes the following Regulations:—

*Citation and Commencement*

1. These Regulations may be cited as the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1964 and shall come into operation on the 26th day of October, 1964.

*Amendment of the Marketing of Potatoes Regulations (Northern Ireland) 1964*

2. For the definition of 'Packer' in article 3 of the Marketing of Potatoes Regulations (Northern Ireland) 1964(a) there shall be substituted the following definition:—

"'Packer' means the grower or licence-holder who packs potatoes for inspection by an authorised officer or on whose behalf potatoes are so packed."

3. For paragraphs (1) and (2) of article 8 of the Marketing of Potatoes Regulations (Northern Ireland) 1964 there shall be substituted the following paragraphs:—

"(1) Subject to the provisions of paragraph (2B), the fee payable to the Ministry in respect of an inspection of potatoes shall be three shillings per ton or part of a ton of potatoes inspected.

(2) Save as provided in paragraph (2A), the said fee shall be payable by the licence-holder for whom or on whose behalf the potatoes are inspected.

(2A) Where—

(a) potatoes which have previously been inspected by an authorised officer and which have not been certified by him in accordance with section 3(1)(b) of the Act are presented for further inspection at the place at which they were packed; and

(b) as the result of such further inspection the potatoes are still not certified as aforesaid—the said fee shall be payable by the packer.

(2B) Where potatoes which have not previously been inspected are presented for inspection at the place at which they were packed and are not certified by an authorised officer in accordance with section 3(1)(b) of the Act, no fee shall be payable in respect of such inspection."

#### EXPLANATORY NOTE

*(This note is not part of the Regulations but is intended to indicate their general purport.)*

These Regulations amend the Marketing of Potatoes Regulations (Northern Ireland) 1964.

They prescribe the fee payable for an inspection of potatoes under section 3(3) of the Marketing of Potatoes Act (Northern Ireland) 1964, how the fee shall be calculated and by whom the fee shall be payable.
