EXPLANATORY NOTE

(This note is not part of the Regulations and does not purport to be a legal interpretation.)

The effect of these regulations will be to alter the commencing date for the annual close season for angling in the River Mourne, its lakes and tributaries, from the 1st October to the 11th October in each year from 1964 to 1966 inclusive. The date in which the close season for angling ends will remain unchanged at 31st March in each year.

FOYLE FISHERIES

Foyle Area (Control of Netting) (Amendment) Regulations 1964

REGULATIONS, DATED 12TH FEBRUARY, 1964, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR LANDS OF THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISHERIES ACT 1952 AND OF THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission, hereinafter referred to as "the Commission", in exercise of its powers under Section 13 of the Foyle Fisheries Act 1952, and Section 13 of the Foyle Fisheries Act (Northern Ireland) 1952, hereby makes the following regulations:—

1. These regulations may be cited as the Foyle Area (Control of Netting) (Amendment) Regulations 1964, and shall come into force on the first day of April, 1964.

2. The Foyle Area (Control of Netting) Regulations 1956(a) shall be amended as follows:—

(a) For paragraph (2) of Article 4 shall be substituted the following paragraph:—

“(2) The Licence tag referred to in paragraph (1) of this article shall be supplied annually to each licence holder by the Commission and will remain the property of the Commission to whom it shall be returned by the fifteenth day of September each year.”

(b) Paragraph (3) of Article 4 shall be deleted.

(c) Paragraph (4) of Article 4 shall be renumbered paragraph (3).
