ROYAL ULSTER CONSTABULARY

Pensions

ORDER, DATED 18TH MARCH, 1964, MADE BY THE MINISTER OF HOME AFFAIRS WITH THE CONCURRENCE OF THE MINISTER OF FINANCE UNDER THE CONSTABULARY AND POLICE (IRELAND) ACT 1919, AS APPLIED BY THE CONSTABULARY ACT (NORTHERN IRELAND) 1922, AND THE CONSTABULARY (PENSIONS) ACT (NORTHERN IRELAND) 1949.

I, the Right Honourable William Craig, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by section 2 of the Constabulary Act (Northern Ireland) 1922(a), section 4 of the Constabulary and Police (Ireland) Act 1919(b), as applied by the said Act of 1922, and by the Constabulary (Pensions) Act (Northern Ireland) 1949(c), and of all other powers enabling me in that behalf, do hereby order as follows:—

Citation

1. This Order may be cited as the Royal Ulster Constabulary Pensions (Amending) Order 1964, and shall be construed as one with the Royal Ulster Constabulary Pensions Orders 1949 to 1963, and those Orders and this Order may be cited together as the Royal Ulster Constabulary Pensions Orders 1949 to 1964.

Commencement

2.—(1) This Order, except Articles 5 and 6, shall have effect from 30th March, 1964.

(2) Articles 5 and 6 shall have effect from 1st August, 1963.

Certificate

3. I certify that section 4(2) of the Constabulary and Police (Ireland) Act 1919, which as applied by the Constabulary Act (Northern Ireland) 1922, provides that a draft of any Order proposed to be made under the said section shall be submitted to the Representative Body or Bodies constituted by that Act and representing any rank or ranks affected, and that before the Order is made the Minister of Home Affairs shall consider any representations made by such Body or Bodies, has been fully observed.

Interpretation

4.—(1) In this Order, unless the contrary intention appears, a reference to a paragraph shall be interpreted as a reference to a paragraph in the Schedule to the Royal Ulster Constabulary Pensions Order 1949(d), and a reference to an Appendix shall be interpreted as a reference to an Appendix to the said Schedule.

(2) In this Order the expressions "1957 Order(e)" and "1963 Order(f)" mean in each case the Royal Ulster Constabulary Pensions (Amending) Order made in the year mentioned.

AMENDMENTS OF THE SCHEDULE

5. For paragraph 17(1) (which relates to awards to widows where the entitlement arose before 5th July, 1948) there shall be substituted the following:---

"17.--(1) Subject to paragraph 20---

- (a) nothing in this Order shall affect any widow's pension or gratuity granted under the Royal Ulster Constabulary Pensions Orders; and
- (b) where immediately before 5th July, 1948, a widow was entitled to such a pension or gratuity she shall continue to be so entitled in all respects as if this Order had not come into force:

Provided that such a pension shall in each case be that provided for in the said Orders without taking into account, except in the manner hereinafter specified, any increase under the Pensions (Increase) Acts (Northern Ireland) 1944(a) and 1947(b)."

6. After paragraph 20(3) as set out in Article 18 of the 1963 Order (which relates to the conditions governing a widow's pension on her remarriage and again becoming a widow or that marriage being dissolved) there shall be added the following:—

"(4) This paragraph shall apply, in place of paragraph 18 of the First Schedule to the Royal Ulster Constabulary Pensions Order 1923(c), to a widow's pension granted under the Royal Ulster Constabulary Pensions Orders."

7. For paragraph 26 as set out in Article 27 of the 1957 Order (which relates to the duration of a child's allowance) there shall be substituted the following paragraph:

"26. A child's allowance shall be payable up to the time when the child attains the age of nineteen years:

Provided that the allowance shall not be payable for any period after the child has attained the age of sixteen years during which he is neither undergoing full-time education nor is an apprentice."

8. After paragraph 60 there shall be added the following paragraph :---

"61. No payment shall be made under this Order on account of a widow's pension or child's allowance for a period before an amendment to this Order took effect save in so far as the said payment would have been so made had the amendment in question not been made."

9. For Part IX of Appendix II, as set out in Article 27 of the 1963 Order (which relates to the extent to which certain national insurance benefits are to be taken into account in calculating a widow's pension), there shall be substituted the following Part:—

PART IX

. COMPUTATION OF WIDOW'S BENEFIT AND RETIREMENT PENSIONS

1.-(1) For the purposes of Parts I, III and VII of this Appendix-

(a) where a widow is entitled under the National Insurance Act (Northern Ireland) 1946(d) to a widow's allowance or retirement pension which is increased under section 22 of the said Act, that allowance or pension shall be deemed not to have been so increased;

- (b) where a widow is entitled under the said Act to a widowed mother's allowance or a retirement pension which is increased under section 5 of the National Insurance Act (Northern Ireland) 1959(a) the allowance or pension shall be deemed not to have been so increased;
- (c) where a widow is entitled under the said Act of 1946 to a widowed mother's allowance under section 16(1)(b)(i) of that Act that allowance shall be deemed to be less than it is by the amount specified in sub-paragraph (2).
- (2) The amount referred to in paragraph 1(1)(c) is the aggregate of—
- (a) thirty-seven shillings and sixpence for the only or eldest child included in the widow's family within the meaning of the Family Allowances Act (Northern Ireland) 1945(b);
- (b) twenty-nine shillings and sixpence for the second child so included, and
- (c) twenty-seven shillings and sixpence for each subsequent child so included."

10. For paragraphs 3(a) and (b) of Part III of Appendix III as set out in Article 28 of the 1963 Order (which Part relates to a discretionary increase in a child's allowance) there shall be substituted the following sub-paragraphs:—

- "(a) in the case of a child who is the only or eldest child included in a family within the meaning of the Family Allowances Act (Northern Ireland) 1945 to a rate not exceeding thirty-seven shillings and sixpence a week;
 - (b) in the case of the second child so included to a rate not exceeding thirty-four shillings and sixpence a week;
 - (c) in the case of each subsequent child so included to a rate not exceeding thirty-two shillings and sixpence a week."

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

This Order, which amends the Royal Ulster Constabulary Pensions Order 1949, relates to widows' pensions and children's allowances.

Articles 5 and 6 provide that the conditions relating to a widow's pension on remarriage and again becoming a widow or on that marriage being dissolved, granted under the 1949 Order, shall apply also to widows' pensions granted prior to 5th July, 1948.

Article 7 extends up to the time he attains the age of 19 years the period for which an allowance is payable to a child who is undergoing full-time education or is an apprentice.

Article 8 provides that increased payments authorised by amending Orders shall not be made before the Orders take effect.

Article 9 adjusts the extent of the abatement of a widow's pension by a widowed mother's national insurance allowance.

Article 10 increases the amounts of certain children's allowances or increases in allowances payable at the Ministry's discretion.

I, the Right Honourable William Craig, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by the Special Constables Act 1914(a), as extended and amended by section 8 of the Constabulary Act (Northern Ireland) 1922(b), and by section 4(4) of the Constabulary (Pensions) Act (Northern Ireland) 1949(c), and of all other powers enabling me in that behalf, do hereby make the following Regulations:—

Citation

1. These Regulations may be cited as the Ulster Special Constabulary Pensions (Amending) Regulations 1964, and shall be construed as one with the Ulster Special Constabulary Pensions Regulations 1950 to 1963, and those Regulations and these Regulations may be cited together as the Ulster Special Constabulary Pensions Regulations 1950 to 1964.

Commencement

2.—(1) These Regulations, except Regulations 4 and 5, shall have effect from 30th March, 1964.

(2) Regulations 4 and 5 shall have effect from 1st August, 1963.

Interpretation

3.—(1) In these Regulations, unless the contrary intention appears, a reference to a Regulation or a Schedule shall be interpreted as a reference to a Regulation or a Schedule in or to the Ulster Special Constabulary Pensions Regulations 1950(**d**).

(2) In these Regulations the expressions "1958 Regulations(e)" and "1963 Regulations(f)" mean the Ulster Special Constabulary Pensions (Amending) Regulations made in the year mentioned.
