INTOXICATING LIQUOR

Claims Fund: Charges in respect of Licences

RULES, DATED 5TH MAY, 1964, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 3 OF THE INTOXICATING LIQUOR ACT (NORTHERN IRELAND) 1923, AS AMENDED BY THE INTOXICATING LIQUOR (FINANCE) ACT (NORTHERN IRELAND) 1925, AND BY SECTION 14 OF THE FINANCE ACT (NORTHERN IRELAND) 1959.

The Ministry of Finance in the exercise of the powers conferred upon it by Section 3 of the Intoxicating Liquor Act (Northern Ireland) 1923(a), as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland) 1925(b), and by Section 14 of the Finance Act (Northern Ireland) 1959(c), and of all other powers enabling it in that behalf hereby makes the following Rules:—

1. These Rules may be cited as the Intoxicating Liquor (Claims Fund Charges) Rules (Northern Ireland) 1964.

2. In pursuance of Section 3 of the Intoxicating Liquor Act (Northern Ireland) 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland) 1925, and by Section 14 of the Finance Act (Northern Ireland) 1959, the Ministry of Finance hereby prescribes that the rates at which Claims Fund Charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending the 30th September, 1965, shall be 11s. for each pound sterling of the maximum rates of charge authorised by Sub-Section (3)(b) of Section 3 of the Intoxicating Liquor Act (Northern Ireland) 1923, as amended as aforesaid.

EDUCATION

Institutions of Further Education: Teachers' Salaries and Allowances

REGULATIONS, DATED 7TH MAY, 1964, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947-1963.

The Ministry of Education, in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Institutions of Further Education (Salaries and Allowances) Amending Regulations (Northern Ireland) 1964.
2. The existing Regulations hereby amended are the Institutions of Further Education (Salaries and Allowances) Regulations (Northern Ireland) 1963(b).
3. After paragraph (3) of Regulation 19 of the existing Regulations there shall be added the following proviso:—

“Provided that this paragraph shall not apply to any period of vacation or to any part of such period, if the teacher satisfies the Ministry that during such period, or such part of such period as the case may be, he was in all respects fit to undertake teaching duties.”

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

Regulation 19(3) of the principal Regulations provides that a teacher who is absent because of illness and who does not resume his teaching duties for 10 successive working days immediately before or immediately after or immediately before and after a period of school vacation shall be regarded as absent because of illness for that period of vacation.

The purpose of this amendment is to ensure that if a teacher is fit for duty during a vacation period the vacation will not be treated as sick leave.
