WAGES COUNCILS

Wages Regulation (Brush and Broom)

Order, dated 9th August, 1965, made by the Ministry of Health and Social Services under the Wages Councils Act (Northern Ireland) 1945.

The Ministry of Health and Social Services, in exercise of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland) 1945(a), hereby makes the following Order to give effect to wages regulation proposals received from the Brush and Broom Wages Council (Northern Ireland):—

Citation

1. This Order may be cited as the Brush and Broom Wages Regulation (Amendment) Order (Northern Ireland) 1965.

Commencement

2. The wages regulation proposals set out in the Schedule shall come into operation on the specified date.

Interpretation

3. In this Order the expression "the specified date" means the 17th day of August, 1965, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

SCHEDULE

Statutory Minimum Remuneration

- 3. in the heading to paragraphs 3 to 8, and 9 and 10, for '125 PER CENT., OR 25s. IN THE £' there were substituted '137½ PER CENT., OR 27s. 6d. IN THE £.'
- 4. for paragraph 11 there were substituted the following paragraph—

"OVERTIME-ALL WORKERS

Paragraph 11.

Overtime rates are payable as follows:-

- A. Workers employed on time work:
 - (a) In any week (exclusive of any time for which double time is payable under the provisions of (b) and (c)), for time worked in excess of 41 hours—
 - (i) for the first three hours ... TIME-AND-A-QUARTER
 - (ii) thereafter ... TIME-AND-A-HALF

Provided that where in any week a worker is allowed a holiday on any day of customary holiday the said period of 41 hours shall be reduced by 8 hours 12 minutes in respect of each such holiday which is allowed on a day normally worked by the worker.

(b) On Sunday or a customary holiday—.

For all time worked Double Time

(c) On Saturday—

For all time worked after mid-day ... Double Time

B. Workers employed on piece work:

Workers employed on piece work are entitled to receive, in respect of each hour of overtime worked, in addition to the general minimum piece rates applicable or, where no such general minimum piece rates have been fixed, in addition to piece rates, each of which would yield, in the circumstances of the case, to an ordinary worker, at least the same amount of money as the appropriate piece work basis time rate

an amount equivalent to one-quarter, one-half or the whole of the appropriate piece work basis time rate

according as the overtime payable under the provisions of subparagraph A, if the worker has been employed on time work, would have been equivalent to time-and-a-quarter, time-and-a-half, or double time, respectively."

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order, which comes into operation on 17th August, 1965, amends the Brush and Broom Wages Regulation Order (Northern Ireland) 1964 (Order N.I.B.B. (91)), by increasing the statutory minimum remuneration fixed by that Order, and by reducing the normal working week from one of 42 hours to one of 41 hours.

New provisions in the Schedule are printed in italics.

 - "Member" means a member of the Force.
