EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order, which comes into operation on 9th February, 1965, amends the Boot and Shoe Repairing Wages Regulation Order (Northern Ireland) 1960 (Order N.I.B.S. (85)), as amended by the Boot and Shoe Repairing Wages Regulation (Amendment) Order (Northern Ireland) 1963 (Order N.I.B.S. (93)), by increasing the statutory minimum piece rates fixed by those Orders, and by reducing the normal working week from one of $43\frac{1}{2}$ hours to one of 42 hours. Order N.I.B.S. (93) is revoked.

New provisions in the Schedule are printed in italics.

SUPREME COURT, NORTHERN IRELAND PROCEDURE

The Rules of the Supreme Court (Northern Ireland) (No. 1) 1965

We, the Northern Ireland Supreme Court Rules Committee, being the authority having for the time being power under section 7 of the Northern Ireland Act 1962(a) to make, amend or revoke rules regulating the practice and procedure of the Supreme Court of Judicature of Northern Ireland, hereby exercise those powers and all other powers enabling us in that behalf as follows:—

1. For rule 9 of Order XXXVIII of the Rules of the Supreme Court (Northern Ireland) 1936(b), which relates to affidavits, there shall be substituted the following rule:—

"9.—(1) Every affidavit shall state the name, occupation and address of the deponent.

(2) An affidavit of service shall also state by whom the document was served, the day of the week and the date on which it was served, where it was served and how.

(3) Where a document is served by delivering it to any person, then the affidavit of service shall state how the deponent identified the person served."

2. In paragraph (2) of rule 35 of Order XLII, which relates to execution, for the words "personally on the debtor" there shall be substituted the words "on the debtor by recorded delivery or personally".

3. For rule 4 of Order LXIII, which relates to sittings and vacations, there shall be substituted the following rule:---

every day of the year except-

- (a) Saturdays and Sundays;
- (b) St. Patrick's Day, Good Friday, the Monday and Tuesday after Easter Sunday, Christmas Day, Boxing Day and the two next following working days;
- (c) days appointed for public thanksgiving or mourning, or as public or bank holidays under the Bank Holidays Act 1871, the Holidays Extension Act 1875, or any Act extending or amending the same; and

(d) such other days as the Lord Chief Justice may appoint."

4. For rule 177 of Order LXXXVIII, which relates to bankruptcy, there shall be substituted the following rule:

"177. The offices of the Court shall be open daily in accordance with the provisions of rule 4 of Order LXIII."

5. Item 27 of Part V of Appendix S, which relates to costs, shall be 1 deleted.

6. These rules may be cited as the Rules of the Supreme Court (Northern Ireland) (No. 1) 1965, and shall come into force on the 1st day of March, 1965.

EXPLANATORY NOTE

(This note is not part of the rules, but is intended to indicate their general purport.)

Rule 1 revises the provisions of rule 9 Order XXXVIII, relating to affidavits of service.

Rule 2 provides for the service of a summons by recorded delivery under rule 35(2) of Order XLII as an alternative to personal service.

Rules 3 and 4 make provision for the closing of Court offices on holidays, following the change in the date of the August bank holiday.

Rule 5 makes an alteration in the items relating to bankruptcy costs.

STATISTICS OF TRADE

Census of Retail Distribution and Other Services (1966) (Scope of the Census)

Order, dated 20th January, 1965, made by the Ministry of Commerce under Section 1(4) of the Statistics of Trade Act (Northern Ireland) 1949.

The Ministry of Commerce, in exercise of the powers conferred upon it by Section 1(4) of the Statistics of Trade Act (Northern Ireland) 1949(a) and of all other powers enabling it in that behalf, hereby makes the following Order:

Citation

1. This Order may be cited as the Census of Retail Distribution and Other Services (1966) (Scope of the Census) Order (Northern Ireland) 1965.

Interpretation

2. In this Order "the census" means the census of retail distribution and other services to be taken in the calendar year 1966 pursuant to the Census of Retail Distribution and Other Services (1966) Order (Northern Ireland) 1964(b).

Scope of the Census

3.—(1) The undertakings of the classes or descriptions set forth in the First Schedule are hereby prescribed as the undertakings in the field of retail distribution to which the census shall apply.
