(3) Where, as the result of a test made under this Article, the Ministry issues a Notice under Article 13 of the Principal Order, Article 14(5)(a) of the said Order shall cease to have effect.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order makes a number of amendments to the Brucellosis Order (Northern Ireland) 1964 which have become necessary because of the stage reached in the brucellosis eradication programme. The principal change is that an owner who chooses to retain reactors in his herd may now do so only for a limited period the extent of the period depending on whether or not he is a licensed milk producer.

MARKETING OF POULTRY

REGULATIONS, DATED THE 1ST DAY OF FEBRUARY, 1965, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 9 OF THE MARKETING OF POULTRY ACT (NORTHERN IRELAND) 1949(a).

The Ministry of Agriculture in exercise of the power conferred on it by Section 9 of the Marketing of Poultry Act (Northern Ireland) 1949, and of every other power enabling it in that behalf, hereby makes the following Regulations:—

Short Title and Commencement

1. These Regulations may be cited as the Marketing of Poultry (Amendment) Regulations (Northern Ireland) 1965, and shall come into operation on the 1st day of August, 1965.

Amendment to the Marketing of Poultry Regulations

- 2. The Marketing of Poultry Regulations (Northern Ireland) 1963(b) are hereby amended as follows:—
- (1) For Paragraph 10 of Section A of Part I of the Third Schedule thereto, the following paragraph shall be substituted:—
 - "10. Only poultry which have been killed on his own premises shall be eviscerated."

- (2) At the end of Section B of Part I of the Third Schedule thereto, there shall be added the following paragraph:—
 - "14. Only poultry which have been killed on his own premises shall be eviscerated."
