EDUCATION

Postgraduate Studentships

REGULATIONS, DATED 3RD MAY, 1965, MADE BY THE MINISTRY OF EDUCATION WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTIONS 77 AND 112 OF THE EDUCATION ACI (NORTHERN IRELAND) 1947.

The Ministry of Education (hereinafter referred to as "the Ministry"), in pursuance of the powers vested in it by Sections 77 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following Regulations:

- 1.—(1) These Regulations may be cited as the Postgraduate Studentships . Regulations (Northern Ireland) 1965.
- (2) The Postgraduate Studentships Regulations (Northern Ireland) 1964(b) are hereby revoked.
- 2. After consultation with an Advisory Board composed of such suitably qualified persons as the Ministry may from time to time appoint thereto, the Ministry may make grants (hereinafter referred to as "postgraduate studentships") to students with approved qualifications.
- 3. Postgraduate studentships may be awarded for full-time advanced postgraduate study in subjects within the fields of Science and Technology or of Arts and Social Studies.
- 4. Postgraduate studentships shall be of such amount and be subject to such conditions as may be determined from time to time by the Ministry with the consent of the Ministry of Finance.

MENTAL HEALTH

Payment of Fees

REGULATIONS, DATED 30TH APRIL, 1965, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES, IN CONJUNCTION WITH THE MINISTRY OF FINANCE UNDER THE MENTAL HEALTH ACT (NORTHERN IRELAND) 1961.

The Ministry of Health and Social Services, in exercise of the powers conferred upon it by sections 90 and 112 of the Mental Health Act (Northern Ireland) 1961(a) and in conjunction with the Ministry of Finance hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Mental Health (Payment of Fees) (Amendment) Regulations (Northern Ireland) 1965.
- 2. The Mental Health (Payment of Fees) Regulations (Northern Ireland) 1962(b) shall be amended as follows:—
 - (1) As from the 2nd April, 1962, until the 31st March, 1964, in Regulation 2 for the amount '£3. 3. 0.' where it occurs there shall be substituted the following:—
 - "(a) £4. 4. 0. for consultant or specialist work;
 - (b) £3. 13. 6. for medical work other than consultant or specialist work".
 - (2) As from the 1st April, 1964, in Regulation 2 for the amount '£3. 3. 0.' where it occurs there shall be substituted the following:—
 - "(a) £4. 12. 6. for consultant or specialist work;
 - (b) £4. 0. 0. for medical work other than consultant or specialist work".
