EMERGENCY POWERS

ORDER IN COUNCIL, DATED THE 26TH DAY OF MAY 1966, MAKING REGULATIONS UNDER SECTION 2 OF THE EMERGENCY POWERS ACT (NORTHERN IRELAND) 1926 AS AMENDED BY THE EMERGENCY POWERS (AMENDMENT) ACT (NORTHERN IRELAND) 1964.

ROAD VEHICLES

REGULATIONS, DATED THE 24TH MAY, 1966, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 8 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT (NORTHERN IRELAND) 1929.

The Ministry of Home Affairs in exercise of the powers vested in it by Section 8 of the Motor Vehicles and Road Traffic Act (Northern Ireland) 1929(a), and all other powers enabling it in that behalf, hereby makes the following Regulations:—

Citation and Commencement

1. These Regulations may be cited as "The Road Vehicles (School Crossings) Regulations (Northern Ireland) 1966" and shall come into force on the 1st day of June, 1966.

Revocation

2. The Road Vehicles (School Crossings) Regulations (Northern Ireland) 1965(b) are hereby revoked.

Power of Patrol

3. When a vehicle is approaching a place in a road where children are crossing or seeking to cross the road a School Crossing Patrol shall have power by exhibiting a sign to require the person driving or propelling the vehicle to stop it.

Duty of Driver

4.—(1) When a person has been required under Regulation 3 to stop a vehicle—

- (a) he shall cause the vehicle to stop before reaching the place where children are crossing or seeking to cross and so as not to stop or impede their crossing; and
- (b) he shall not put the vehicle in motion again so as to reach the place in question so long as the sign continues to be exhibited.

(2) A person who fails to comply with the preceding paragraph shall be guilty of an offence.

Interpretation

5.—(1) In these Regulations "School Crossing Patrol" means a person appointed in accordance with a Scheme framed under Section 51(5) of the Education Act (Northern Ireland) 1947(a) who is wearing the uniform described in Part I of the Schedule and is equipped with a sign either—

- (a) of the size, colour and type shown in Diagram I, Part II of the Schedule; or
- (b) until the 31st July, 1966, or such later date as may be authorised by the Ministry of Home Affairs of the size, colour and type shown in Diagram II, Part II, of the Schedule.

Subject, however, in either case to the provisions of Part III of the Schedule.

SCHEDULE

PART I

The uniform mentioned in Regulation 5 shall consist of :---

(a) a peaked cap;

- (b) a dust coat or raincoat, in either case white in colour or of such other colour in fluorescent material as may be authorised by the Ministry of Home Affairs;
- (c) an armband bearing the words "School Crossing Patrol" to be worn over the coat or raincoat.

1. Any variation in a dimension (other than as to the height of a letter) specified in either of the foregoing diagrams shall be treated as permitted by these Regulations if the variation:—

- (a) in the case of a dimension so specified as 12 inches or as over 12 inches, does not exceed $2\frac{1}{2}$ % of that dimension;
- (b) in the case of a dimension so specified as 2 inches or as over 2 inches but as under 12 inches, does not exceed 5% of that dimension; or
- (c) in the case of a dimension so specified as under 2 inches, does not exceed 10% of that dimension.

2. Any variation in a dimension as to the height of a letter specified in either of the foregoing diagrams shall be treated as permitted by these Regulations if the variation: —

- (a) in the case of a dimension so specified as 4 inches or as over 4 inches, does not exceed $2\frac{1}{2}$ % of that dimension; or
- (b) in the case of a dimension so specified as under 4 inches, does not exceed 5% of that dimension.

EXPLANATORY NOTE

(This note is not part of these Regulations, but is intended to . indicate their general purport.)

These Regulations re-enact those made in 1965, with the addition of a provision (in Part I of the Schedule) providing for the experimental use of fluorescent coats by School Crossing Patrol men.

Oualifications and Duties of Medical Officers
