### **EXPLANATORY NOTE**

(This note is not part of the Regulations but is intended to indicate their general purport.)

Under the existing Regulations, where there has been a fall in the enrolment of a school the school authorities may be required to terminate the employment of a teacher by the end of the school year i.e. by 31st July. The purpose of the amending Regulations is to enable the teacher to be retained on the staff of the school for the whole or part of the month of August to preserve continuity of employment and salary.

# ROAD TRAFFIC

# **Speed Limits**

Order, dated 6th June, 1966, made by the Ministry of Home Affairs under section 23(4) of the Road Traffic Act (Northern Ireland) 1955.

The Ministry of Home Affairs in exercise of the powers conferred on it by section 23(4) of the Roads Traffic Act (Northern Ireland) 1955(a) (hereinafter referred to as "the Act"), and of all other powers enabling it in that behalf, hereby orders and directs as follows:—

#### Citation and Commencement

1. This Order may be cited as the Roads (Speed Limit) (No. 3) Order (Northern Ireland) 1966 and shall come into operation on 20th June, 1966.

Restriction of Road

2. The length of road specified in the Schedule shall be a restricted road for the purposes of section 23 of the Act.
