36. Inspection. Inspectors have power to inspect every part of the premises by day or by night. They may require the production of registers, certificates and other papers. They may examine any person found on the premises, either alone or in the presence of any other person as they think fit, and may require him to sign a declaration of the truth of the matters about which he is examined. They may also exercise such other powers as may be necessary for carrying the Act into effect. Every person obstructing an Inspector is liable to a penalty. (Sections 146 and 147.)

## EXPLANATORY NOTE

### (This Note is not part of the Order, but is intended to indicate its general purport.)

This Order prescribes the abstract of the Factories Act (Northern Ireland) 1965 required by Section 138(1) of that Act to be kept posted at the principal entrances of a factory at which employed persons enter, for use in the case of any dock, wharf, quay, warehouse, line or siding to which Section 123 of that Act applies.

The abstract prescribed by this Order is in substitution for that prescribed by as much of the Factories (Forms and Particulars) Order (Northern Ireland) dated 7th June, 1950, as deals with Form N.I.2 which is revoked.

## NATIONAL INSURANCE (INDUSTRIAL INJURIES)

#### Benefit

REGULATIONS, DATED 29TH JUNE 1966, MADE BY THE INDUSTRIAL INJURIES JOINT AUTHORITY AND THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACTS (NORTHERN IRELAND) 1966.

The Industrial Injuries Joint Authority, in exercise of powers conferred by section 19(4) of the National Insurance (Industrial Injuries) Act (Northern Ireland) 1966(a), and the Ministry of Health and Social Services, in exercise of powers conferred by section 5(2) of that Act and section 14(6) of the National Insurance (No. 2) Act (Northern Ireland) 1966(b), and of all other powers enabling them in that behalf, hereby make the following regulations:

### Citation and commencement

1.—(1) These regulations, which may be cited as the National Insurance (Industrial Injuries) (Benefit) Amendment (No. 3) Regulations (Northern Ireland) 1966, shall be read as one with the National Insurance (Industrial Injuries) (Benefit) Regulations (Northern Ireland) 1948(c) (hereinafter referred to as "the principal regulations") and, subject to the provisions of the next following paragraphs, shall come into operation on 6th October 1966.

(2) This regulation and regulation 3 shall come into operation on 6th July 1966:

Amendment of regulation 12 of the principal regulations

2. In regulation 12(b) of the principal regulations (period of payment of higher rate of widow's pension) after the words "during the 13 weeks" there shall be inserted the words "or, in a case when the death of the deceased took place on or after 6th July 1966, during the 26 weeks".

Transitional awards of widow's pension

3. When before 5th October 1966, an award of widow's pension under section 19 of the Act is made to a widow in respect of the death of the deceased which took place not more than 13 weeks before that date that pension may be awarded for the period of 26 weeks provided for by regulation 12(b) of the principal regulations, as amended by regulation 2 of these regulations, at the rate provided for by the said regulation 12(b).

Amendment of regulations 25A, 25B and 25C of the principal regulations

4.-(1) Paragraphs (1) and (2) of regulation 25Å(a) of the principal regulations are hereby revoked.

(2) Regulation 25B(b) of the principal regulations is hereby revoked.

(3) Paragraphs (1) and (3) of regulation 25C(a) of the principal regulations are hereby revoked.

## EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to *indicate their general purport.*)

These Regulations amend the National Insurance (Industrial Injuries) (Benefit) Regulations (Northern Ireland) 1948 so as to give effect to certain provisions of the National Insurance (No. 2) Act (Northern Ireland) 1966. Regulation 2 extends the period during which a widow's pension is payable at a rate higher than the standard rate from 13 weeks immediately following the husband's death to 26 weeks except in cases of death more than 13 weeks before 5th October (when the relevant provision of the Act comes into operation) and regulation 3 makes a transitional provision to enable awards to be made in the 13 weeks before that date for the 26 week period. Regulation 4 revokes provisions which are no longer necessary because similar provisions in the National Insurance (Unemployment and Sickness Benefit) Regulations (Northern Ireland) 1961 are applied to injury benefit by the Act, and makes consequential amendments.
