SUPPLEMENTARY BENEFITS

Commencement Order (Northern Ireland) 1966

Order, dated 10th August 1966, made by the Minister of Health and Social Services under the Supplementary Benefits &c. Act (Northern Ireland) 1966.

Whereas it is provided by section 43 of the Supplementary Benefits &c. Act (Northern Ireland) 1966(a) (hereinafter referred to as "the Act") that that section shall come into operation on the passing of the Act and that the remaining provisions thereof shall come into operation on such day or days as the Minister may by order appoint:

Now, therefore, I, the Right Honourable William James Morgan, Minister of Health and Social Services, hereby make the following order:

1. The day appointed for the coming into operation of any provision of the Act specified in column 1 of the Schedule, so far as that provision relates to any subject matter specified in column 2 of the Schedule, shall be the date specified in column 3 of the Schedule in relation to that subject matter.

2. This order may be cited as the Supplementary Benefits (Commencement) Order (Northern Ireland) 1966.
